i)	What is the information provided in the specified application form at Sl No. 11(e) & 11(f)?	The application form was filled up by the applicant and therefore details filled in the application form is already available with the applicant.
ii)	What is the criteria used to issue interview call letter no. HQ/HR/4/Absorption/3 dated 23.02.2013 to the undersigned? Please mention detail.	The interview call letters to the applicants were issued on the basis of details mentioned by the applicants in the application form. The form was filled up by the applicant and therefore, there is no reasonability for asking this information. As per records available, Shri Husain Ahmad, S/o Mohd. Suleman was called for interview on 20.03.2013 at 1.30 p.m. and he reported for the document verification.
iii)	Was the undersigned present at the time of interview? Please mention the date & time.	
iv)	On which ground undersigned was not allowed to appear for interview in front of Interview Board? Please mention the reasons clearly.	Shri Husain Ahamad had applied for the post of Manager (S&T) on immediate absorption basis. As per advertisement, officers working in E-3 IDA pay scales in Central PSUs were eligible for the post of Manager. The last date for submitting the application was 60 days from the date of publication in Employment News. The advertisement was published on 18.08.2012 and therefore, the last date was 17.10.2012. As such the crucial date for deciding the eligibility criteria was 17.10.2012.
v)	What is effective date of the pay scale E-3 grade mentioned in the Order letter (issued by BSNL) of the pay scale presented by the undersigned during paper verification before interview.	As per documents produced during document verification before interview by Shri Husain Ahamad, he was promoted from E-2 to E-3 IDA pay scale vide Memo No. Staff/SSA/E2 to E3/2012/18 dated 21.02.2013. Therefore, Shri Husain Ahamad was not working in E-3 and was not eligible on 17.10.2012, which is the crucial date for deciding the eligibility criteria and hence he was declared ineligible as per item 4 of the instructions mentioned in the advertisement.
