Sub : Naming of new DFC station over WDFC as 'New Motidau' instead of New Bhandu.

Station details and Inter Station Distance for New Palanpur (PNUN) – New Bhandu (BHUN) section of Western DFC (WDFC) Division on DFCR, were notified vide above referred DFCR/BD Circulars. Based upon the representation of local residents received from Hon'ble MP (through Railway Board's letter under reference 2) and NOC received from Civil Administration, competent authority has approved the name of this station as New Motidau instead of its previous name as New Bhandu. GS/IRCA has approved for keeping the same Alphabetical and Numerical Codes issued to 'New Bhandu' for the new name. Details are mentioned below :




