Vide DFCR/BD Circular under reference (2), Station details and Inter Station Distances of stations between New Saphale to New Umbergaon Road of Western DFC (WDFC) Division on DFCR along with distance were notified.

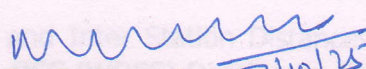
