DFCR Business Development Circular No. 21

Sub: Intra DFC small cargo in NMGHS Cargo Vans.


1. A pilot project for transportation of small cargo/parcel traffic in NMGHS cargo vans by DFCCIL between New Rewari and New Palanpur stations of DFCCIL is operating successfully. It is now planned to introduce the services between New Rewari and New Palanpur for all customers.
2. To start with, the service will operate between New Rewari and New Palanpur stations of DFC with NMGHS cargo vans.
3. For booking the NMGHS cargo van, customers may register on Parcel Management System at www.parcel.indianrail.gov.in under 'Parcel Services' tab by clicking on 'DFC Booking' and 'Sign Up'.
4. Customers can place indent for at least 01 (one) NMGHS (or more in multiples of one unit) for each booking on 100% advance freight payment. Freight payment is online.
5. Number of indents for each day shall be restricted by DFCCIL as per availability and operational feasibility.
6. The wagons will be supplied on a 'first come first serve' basis. There shall be no refund if the allotted cargo van is not utilized by the party for loading on the scheduled day of departure.
7. In case of non-supply of NMGHS cargo van after 10 days of scheduled day of loading, cancellation of indent is permitted and full refund shall be granted.
8. The NMGHS traffic shall depart daily as per the schedule from both the Originating-Destination pair of stations.
9. The freight shall be charged at Indian Railways Parcel rates for stenciled carrying capacity of the NMGHS (which is normally 18 Tons) at 'Scale P +20%', as notified by Ministry of Railway vide Freight Marketing circular no. 14 of 2022 or as modified from time to time. All the rules of parcel traffic prevalent over Indian Railways shall be applicable on this traffic.

10. Date of commencement of the service shall be 16.10.2023. The customers interested to book NMGHS cargo vans can book it online w.e.f. 14.10.2023 (18.30 hrs onward).
11. The schedule timings of the service shall be as under: -

12. Advance booking shall be permitted upto 90 days in advance. However, advance booking of NMGHS service shall not be permitted less than 24 hours of the scheduled departure time of the train.
