
- Sub : Opening of DFCCIL's Gati Shakti Multi-Modal Cargo Terminal at New Bhaupur (DGBN) served by New Bhaupur for booking and handling goods traffic.

With reference to the above subject, by exercising the powers of Railway Administration, as delegated vide letter under reference (1), it has been decided to open DFCCIL's Gati Shakti Multi-Modal Cargo Terminal at New Bhaupur (DGBN) served by New Bhaupur Station open for unless otherwise specified by DFCCIL to book and handle all traffic including coal and coke, which shall be as per the guidelines of 'preferential traffic schedule' issued by Ministry of Railways from time to time as under:

It has been decided to use the line mentioned against the name of the terminal as Goods lines for loading/ unloading of Outward/ Inward traffic booked from/ to the above stations.



Commercial activities at the terminal will be performed by Sr. Executive/ Executive/JM (OP&BD) and the commercial activities in TMS/FOIS will be done by North Central Railway's official nominated for the purpose. The above GCT terminal has been allotted to M/s Kanpur Logistics Park Private Limited for a period of 15 years from the date of LOA. The GCT will function round the clock on all days including Sundays and holidays as per 17.3.1 of GCT policy.




