## DFCR business Development Circular No. 10 of 2024

## All Chief General Managers DFCCIL

Sub: Intra DFC small cargo traffic in NMGHS Cargo Vans.

Ref.: BD Circular no. 21 of 2023 dated 13.10.2023.

- The existing small cargo service operating between New Rewari and New Palanpur stations of DFC shall be extended and now the service shall operate between New Rewari and New Sanand North stations of DFC with NMGHS cargo vans for all customers. With start of operation for small cargo between New Rewari and New Sanand North stations the small cargo service from/to New Palanpur station shall be stopped.
- For booking the NMGHS cargo van, customers registered on Parcel Management System at <u>www.parcel.indianrail.gov.in</u> under 'Parcel Services' under 'DFC Booking' may place indent.
- Indents can be placed for atleast 01 (one) NMGHS or more in multiples of one unit for each booking on 100% advance freight payment.
- 4. Freight and Ancillary Charges, except wharfage charges, are to be paid online.
- Number of indents for each day shall be restricted by DFCCIL as per availability and operational feasibility.
- The wagons will be supplied on a 'first come first serve' basis. There shall be no refund if the allotted cargo van is not utilized by the party for loading on the scheduled day of the departure.
- In case of non-supply of NMGHS cargo van after 10 days of schedule day of loading, cancellation of indent is permitted and full refund shall be granted.
- The NMGHS traffic shall depart daily as per the schedule from both originatingdestination pair of stations.
- 9. The freight shall be charged at Indian Railways Parcel rate for stencilled carrying capacity of the NMGHS (which is normally 18 Tons) at 'Scale P+20%', as notified by Ministry of Railways vide Freight Marketing circular no. 14 of 2022 or as modified from time to time. All rules of parcel traffic prevalent over Indian Railways shall be applicable for this traffic.
- 10. Date of commencement of the service shall be notified shortly. The customers interested to book NMGHS cargo vans can book it online w.e.f. one day prior to date of commencement of the service (10.00 hrs onwards).

11. The tentative schedule timings of the service shall be as under: -

12. Advance booking shall be permitted upto 90 days in advance. However, advance booking of NMGHS service shall not be permitted less than 24 hrs of the scheduled departure time of the train.
