

With reference to the above subject, by exercising the powers of Railway Administration, as delegated vide letter under reference, it has been decided to open New Ahraura Road Jn. (ARWN), New Dagmagpur (DAPN), New Mirzapur (MZPN) and New Unchdih (UNDN) stations of DFC Railway to book and handle Ballast traffic for DFCCIL requirement only for a period of six months i.e. till 24.10.2024:

Commercial activities at the above stations will be performed by Sr. Executive/ Executive (OP&BD) posted at these stations. All concerned please note and take necessary action accordingly.




