Sub : Commencement date of Commercial Operation of New Electrified BG DFC Single Rail Line between New Bhandu to Existing IR Mahesana Yard (Mahesana connecting line UP & DN RTR) from KM 0.000 to KM : 7.197 (A part of New Sanand North to New Rewari) (Kilometrage reckoned as 0.000 for RTR Line from Centre line of New Bhandu) for Public Carriage of Goods traffic.
