## Sub: Commencement date of Commercial Operation of New Sanand North (SAUN) to New Makarpura (MPRN) section of WDFC for public carriage of Goods traffic.

  - Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between New Sanand North (SAUN) to New Makarpura (MPRN) of Western DFC (WDFC) Division on DFCR including connectivity portion with Western Railway were notified.
  - 2. Railway Board has conveyed its approval for Opening of New Electrified BG DFC Double Rail line in the Western Dedicated Freight Corridor of Dedicated Freight Corridor Corporation of India Limited from New Sanand North (DFC Km : 559.856) to New Makarpura (DFC Km : 424.763) including 3.750 KM long double line Connectivity from Sanand (South) to IR Sanand, as a part of New JNPT- New Dadri section for Public carriage of Goods Traffic in terms of the provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 29.07.2024 under reference (2). Accordingly, the date on which permission is granted by the Railway Board will be treated as the date for commencement of commercial operation viz. 29.07.2024.
