


DFCR, Business Development Circular No. 34 of 2024
(DFCR/BD – 34 of 2024)

Sub.: Commencement of Commercial Operation of New Electrified BG DFC Single Rail Line between New Khatauli (KATN) and New Pilkhani (PKYN).

- Ref.: (i) DFCR BD Circular NO. 12 of 2023 dated 24.05.2023
(ii) Railway Board's letter No. 2020/Infra/6/13 dated 22.10.2024

Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between **New Khatauli (KATN) and New Saharanpur (SREN)** of Eastern DFC (EDFC) Division on DFCR along with distance were notified. Finance vetted distance between **New Saharanpur (SREN) and New Pilkhani (PKYN)** shall be included in this circular as **6.905 KMs.**

Railway Board has conveyed its approval for Opening of New Electrified BG DFC Single Rail line between New Khatauli Junction (excluding yard) (DFC KM 985.663) and New Pilkhani Junction (excluding yard and connection to Pilkhani IR) (DFC KM 1075.950), section of EDFC having total Route Length of 90.287 KM for Public carriage of Goods Traffic in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 22.10.2024 under reference (2). Accordingly, the date of permission granted by Railway Board viz. 22.10.2024 will be treated as date of commencement of commercial operation.




