Sub.: Commencement of Commercial Operation of New Electrified BG DFC Single Rail Line between New Khurja and New Khatauli.

1. Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between **New Khurja and New Khatauli** section of EDFC were notified. Inter Station Distance of stations over New Khurja - New Khatauli section of EDFC were notified vide Annexure - B of this Circular. Finance Vetted Distance for the below mentioned pair of station is inserted in the table mentioned in Annexure - B:

Railway Board has conveyed its approval vide letter under reference (2) for Opening of Single Rail Line between New Khurja (Excluding Yard) (DFC KM 850.351) and New Khatauli (Excluding Yard) (DFC KM 985.663) (including link line of route length 1.299 Kms connecting DFC New Khatauli with IR Khatauli) of EDFC over DFCR having total route length of 135.132 kms for Public Carriage of Goods Traffic in terms of the provision of Clause 14.4 of Concession Agreement. Accordingly, the date of permission granted by the Railway Board will be treated as date of commencement of commercial operation viz. 10.07.2024.
