Sub: Schedule of Powers delegated to Officers of Operation & Business Development Department in commercial matters.

Ref: 1. Railway Board's letter No. TCR/1618/2020/DFCCIL/1/3328243 dated 24.12.2020.

2. This office letter of even No. dated 19.10.2020.

Commercial Protocol of DFCCIL was submitted to Railway Board for approval vide letter under reference (2). Railway Board informed that DFCCIL has been granted with the status of Railway Administration. It is further mentioned that the commercial rules of Indian Railways will be applicable on DFCCIL mutatis mutandis like a Zonal Railway till Indian Railway is the sole operator.

New Bhaupur to New Khurja section on EDFC has been operationalized commercially on 29.12.2020 and more section will be introduced on DFCR shortly. In view of the commercial operation of EDFC & WDFC, there is an urgent need to delegate the powers to officers of Operation & Business Development Department for smooth functioning of commercial activities. Hence, the powers are delegated to the officers of Operation & Business Development Department as delegated in any rule/policy/ manual to the officers of zonal railway mentioned in the following concurrent table :
