Sub : Commencement date of Commercial Operation of New Electrified BG DFC Double Rail Line from New ERC Deen Dayal Upadhyay Jn. to New Chiraila Pauthu connecting with IR Line near Chiraila Pauthu and New Son Nagar Link to New Son Nagar Jn. Connecting with IR line near Bagha Bishnupur station for Public Carriage of Goods Traffic.

Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of New Deen Dayal Upadhyay Jn. to New Chiraila Pauthu connecting with IR Line near Chiraila Pauthu and New Son Nagar Link to New Son Nagar Jn. section of Eastern DFC (EDFC) Division on DFCR alongwith distance of connectivity portion with East Central Railway (ECR) were notified. Railway Board has conveyed the approval for opening of New ERC Deen Dayal Upadhyay Jn. to New Chiraila Pauthu connecting with IR Line near Chiraila Pauthu and New Son Nagar Link to New Son Nagar Jn. section of EDFC over DFC network alongwith connectivity portion with ECR in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 30.12.2022 under reference (2). Accordingly, the date of permission granted by Railway Board will be treated as date of commencement of commercial operation viz. 30.12.2022.


