DFCR, Business Development Circular No. 05 of 2024 (DFCR/BD - 05 of 2024)

Sub: Commencement date of Commercial Operation of New Electrified BG DFC double Rail Line from New Rewari to New Dadri Junction including IR Connection at Dadri Jn., Asaoti connecting line, ICD connectivity and EDFC connectivity for public carriage of Goods traffic.

Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between New Rewari to New Dadri Junction including IR Connection at Dadri Jn., Asaoti connecting line, ICD connectivity and EDFC connectivity were notified. Railway Board has conveyed it's approval for opening of New Electrified BG DFC double Rail Line from New Rewari to New Dadri Junction from Km: 1334.519 to Km: 1461.388 including IR Connection at Dadri Jn., Asaoti connecting line of length 2.614 km at DFC Ch: 1413.214 (2.050 km from center of Prithala Jn.) and ICD connectivity of length 1.901 km at DFC Ch: 1457.883 (0.421 km from center of New Dadri yard) and EDFC connectivity of length 0.758 Km at DFC Ch: 1459.982 (2.521 Km from center of New Dadri Jn.) for Goods traffic in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 31.01.2024 under reference (2). Accordingly, the date of permission granted by Railway Board will be treated as date of commencement of commercial operation viz. 31.01.2024.
