## DFCR Business Development Circular No. 06 of 2023 (DFCR/BD – 06 of 2023)

- Sub: Opening of 'DFCCIL Gati Shakti Multi-Modal Cargo Terminal at New Rewari' served by New Rewari station for handling container traffic.

With reference to the above subject, by exercising the powers of Railway Administration, as delegated vide letter under reference (1), it has been decided to open the following GCT Terminal on WDFC/DFC Railway as Full Rake Terminal to handle **Inward and Outward Container traffic at Line No. 10 of New Rewari station** with immediate effect :

2. Commercial rules of Indian Railways will be applicable on DFCCIL *mutatis mutandis* like a Zonal Railway. Commercial activities at the above GCT Terminal will be performed by DFCCIL's Sr. Executive/ Executive (OP&BD) and commercial activities in TMS/FOIS will be done by NWR's official nominated for the purpose. The above GCT Terminal has been allotted to M/s Pristine Mega Logistics Park Pvt. Ltd. for a period of 05 (five) years from 17.02.2023 to 16.02.2028 (under reference 2).

3. Untill the installation of weighbridge by GCTO, booking of consignment will be done on SWA (sender's weight accepted). Reweighment at associated weighbridge is compulsory in domestic containers or if any stuffing/ de-stuffing is done at the terminal. All concerned to please note and take necessary action accordingly.
