


DFCR, Business Development Circular No. 10 of 2023
(DFCR/BD – 10 of 2023)

Sub : DFC station details of New Boraki (BRKN) over New Khurja – New Boraki section over EDFC and Inter Station Distance thereof.

Ref : Railway Board's letter 2020/Infra/6/13 Dated 24.04.2023.

1. The competent authority has accorded the administrative approval for naming, Inter Station Distance & opening of 01 (One) new DFC station over New Khurja (KRJN) to New Boraki (BRKN) section over Eastern DFC (EDFC) Division on DFCR and it's connectivity portion with IR.
2. The Alphabetical Codes and Numerical Codes in respect of this DFC stations have been assigned by Indian Railway Conference Association (IRCA). Detail of station on New Khurja (KRJN) to New Boraki (BRKN) section over Eastern DFC (EDFC) is attached as Annexure-'A'.
3. The Inter Station Distances of stations between New Khurja (KRJN) to New Boraki (BRKN) section over Eastern DFC (EDFC) is attached as Annexure – 'B'. Inter Station Distances of connectivity portion of this section over EDFC with NCR is attached as Annexure – 'C'.
4. Railway Board has conveyed the approval for opening of New DFC Double Rail Line on EDFC from New Khurja to New Boraki including DFC connectivity with IR Dadri yard, WDFC Link & connecting DFC New Boraki Yard with IR Dadri yard Dn. Loop through Rail flyover for Public Carriage of Goods traffic in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 24.04.2023 under reference. Accordingly, the date of permission granted by Railway Board will be treated as **date of commencement of commercial operation viz. 24.04.2023** for this section.


