Sub: Commencement date of Commercial Operation of New DFC Rail Line in EDFC of DFCCIL for Public Carriage of Goods traffic.

Ref: 1. Railway Board's letter No. 2020/Infra/6/13 dated 12.07.2023.

2. DFCR, BD Circular No. 09 of 2022 dt. 15.11.2022 and 08 of 2023 dated 09.05.2023.

Approval of Railway Board has been received for opening of following sections in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dated 12.07.2023 (under reference 1):

- (i) IR Chunar Junction Yard (Excl.) and Chunar Junction Link Line (DFC KM 157.545 and New Karchana Junction Yard (DFC KM 269.500) including Prayagraj Cheoki Junction Link Line (of 4.860 KMs), Total Length 116.815.
- (ii) New Karchana Junction and IR Iradatganj from DFC KM : 0.000 to DFC KM 8.873, Total Length 8.873 KMs.
- (iii) New Karchanan (DFC KM 269.500) and New Shujatpur (DFC KM 332.150), Total Length 62.650 KMs.
- (iv) New Kanpur (DFC KM 461.671) and New Bhimsen (DFC KM 487.120) including 2.734 KMs Link Line to Bhimsen IR Yard, Total Length 28.183 KMs.
- (v) New Bhimsen (DFC KM 487.120) and New Bhaupur (DFC KM 507.693), Total Length 20.573 KMs.

The date of permission granted by Railway Board i.e. 12.07.2023 will be treated as date of commencement of commercial operation for the above sections. Station details and Inter Station Distances of these sections have already notified vide DFCR/BD Circular under reference (2).
