**(DFCR/BD – 16 of 2024)**

**Sub : Commencement date of Commercial Operation of New Ahraura Road (ARWN) to Jeonathpur (JEP) section of EDFC for public carriage of Goods traffic.**



**2. Railway Board's letter No. 2020/Infra/6/13 dated 29.04.2024.**

1. Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between New Deen Dayal Upadhyaya Jn. to New Bhimsen (excl. New Kanpur to New Shujatpur portion) of Eastern DFC (EDFC) Division on DFCR were notified. Inter Station Distance of connectivity portion with NCR for these DFC Stations were notified vide Annexure – C of this Circular. Finance vetted distance for the below mentioned pair of stations is inserted in the table mentioned at Annexure – C :

Railway Board has conveyed its approval vide letter under reference (2) for Opening of Single Rail Line (Bi-directional link line) between DN JRTR KM 4.300 to DN JRTR KM (-) 2.800 (connecting New Ahraura Road DFC Yard and JEP IR Yard) having total length of 7.100 KMs of EDFC over DFCR for Public carriage of Goods Traffic in terms of the provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 29.04.2024 under reference (2). Accordingly, the date of permission granted by Railway Board will be treated as date of commencement of commercial operation viz. 29.04.2024.




