


DFCR, Business Development Circular No. 17 of 2024
(DFCR/BD – 17 of 2024)

Sub : Commencement date of Commercial Operation of New Pilkhani (PKYN) to Sahnewal (excluding yard) section of EDFC for public carriage of Goods traffic.

Ref : 1. DFCR/BD Circular No. 18 of 2023.
2. Railway Board's letter No. 2020/Infra/6/13 dated 22.05.2024.

Vide DFCR/BD Circular under reference (1), Station details and Inter Station Distances of stations between New Pilkhani (PKYN) to New Chawapail (CHAN) of Eastern DFC (EDFC) Division on DFCR along with distance of connectivity portion with IR were notified.

Railway Board has conveyed its approval, vide letter under reference (2) for Opening of New Electrified BG DFC Single Rail line between New Pilkhani Junction (DFC KM : 1075.950) and Sahnewal IR (excluding yard) (DFC KM 1250.966) including connection from (i) New Pilkhani Jn. (DFC KM : 1075.950) to Pilkhani IR, (ii) New Kalanaur Jn. (KM 1094.861) to Kalanaur IR, (iii) New Shambhu Jn. (DFC KM 1168.965) to Shambhu IR, (iv) New Shambhu Jn. (DFC KM 1171.981) to Rajpura Jn. IR, (v) New Sarai Banjara Jn. (DFC KM 1187.6) to Sarai Banjara IR and (vi) New Sirhind Jn. (DFC KM 1203) to Sirhind Jn. IR sections of EDFC having total route length 181.551 KMs (82.001 + 18.911 + 80.639) of EDFC over DFCR in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 22.05.2024 under reference (2). Accordingly, the date of permission granted by Railway Board will be treated as date of commencement of commercial operation viz. 22.05.2024.




