- Sub: Commencement date of Commercial Operation of New Palanpur to New Bhandu and New Palanpur to New Chadotar section over WDFC and it's connecting lines with WR for public carriage of Goods Traffic.

Station details and Inter Station Distance of DFC stations over (1) New Palanpur (PNUN) – New Bhandu (BHUN) and (2) New Palanpur (PNUN) – New Chadotar (CDQN) sections of Western DFC (WDFC) Division on DFCR network alongwith distance of connectivity portion with Western Railway (WR) were notified vide circulars under reference (1).
