Sub: Change in name of DFCR Station from 'New Gholvad' to new name 'New Umbergaon Road'.

- 1. The station details for the DFCR station named New Gholvad, including its Alphabetical & Numerical Codes, Inter Station Distances, and distance for connectivity with IR, were notified via DFCR/BD Circular under reference (i).
- 2. The Competent Authority has now granted administrative approval for renaming the DFCR Station from "New Gholvad" to "New Umbergaon Road." The Indian Railway Conference Association (IRCA) has assigned a new Alphabetical Code for this station.
- 3. The station details for New Gholvad (GVDN) station mentioned in Annexure—'A' of DFCR/BD Circular under reference (i) should be replaced with the following details:
