With reference to the above subject, by exercising the powers of Railway Administration, as delegated vide letter under reference, it has been decided to open DFCCIL's Gati Shakti Multi-Modal Cargo Terminal at New Gothangam (DGGN) served by New Gothangam for inward traffic only (all commodities - including coal & coke and container traffic) as under:

All commercial rules of Indian Railways shall be applicable. Commercial activities at the terminal shall be performed by Sr. Executive/ Executive/JM (OP&BD) at New Gothangam and the necessary feeding in TMS/FOIS shall be done by official of Western Railway from the proxy location nominated (Ankleshwar station of BRC Div.) for the purpose. The above GCT terminal has been allotted to M/s Emirates Logistics India Private Limited for a period of 15 years from the date of LOA.

Details of the DFCCIL's Gati Shakti Multi-Modal Cargo Terminal at New Gothangam under Schedule-2 is as follows:

a. The GCT shall function **Round the Clock** on all days including Sundays and holidays as per 17.3.1 of GCT policy.

b. **Traffic allowed:** Inward rakes only till the time weigh-bridge is commissioned and the High Mast lighting are installed. For handling of outward traffic, a separate notification shall be issued.

- c. **Share of TC/TAC to GCTO**: -1% (minus 1%) i.e. entire TC/TAC shall be retained by IR/DFCCIL and GCTO shall pay an additional amount equivalent to one (01)% of TC/TAC to IR/DFCCIL.
- d. Global code: ERLI.
- e. All concerned should note and take necessary action accordingly.
