- Sub: Commissioning of new Electronic-in-motion weighbridge (EIMWB) at DBLN and BAGN.

Railway Board vide letter under reference (2) above has directed DFCCIL to:

- 1. Work out plan for installation of weighbridge at all its loading points in a time bound manner.
- 2. Till such time, for goods terminal of DFCCIL network, PCOM of concerned Zonal Railway will notify associate weighbridge as well as alternate associate weighbridge.

It is to be mentioned here that the integration of EIMWBs with FOIS at DBLN and BAGN have been done by CRIS. Subsequently test weighment of rakes has been done on 29.05.2025 at DBLN and BAGN respectively and conveyed to CRIS.

Necessary instructions in this regard may be issued to all concerned.
