# DFCR, Business Development Circular No. 07 of 2022 (DFCR/BD – 07/2022)

Sub: Nomination of DFCCIL Officers equivalent to IR officers in line with GCT policy of Ministry of Railways dated 15.12.2021

Ref: 1. Railway Board's Master Circular on 'Gati Shakti Multi-Modal Cargo Terminal (GCT) dated – 2021 dated 15.12.2021

- 2. Railway Board's letter No. 2022/TC(FM)/18/1 dated 28.01.2O22
- 3. This office Circular No. DFCR/BD-02 of 2022 dated 19.05.2022.

Railway Board, vide Circular under ref (1) above, issued policy on Gati Shakti Multi-Modal Cargo Terminal (GCT) for development of terminals for handling rail cargo on Private land, Railway land or partially on Private & partially on Railway Land. Permission has been granted by Railway Board for implementation of the GCT policy over DFCCIL mutatis mutandis.

Accordingly, DFCCIL, vide its circular under ref (3), implemented GCT policy Mutatis Mutandis over DFCCIL. Role and responsibilities of various officers of IR have been elaborated in the GCT policy viz: (a) Divisional level – Sr. DOM, Sr. DCM, Sr. DFM, Sr. DEE (TRD), Sr. DSTE, Sr. DME, Sr. DEN (Coord) and SSE/C&W (b) at Zonal level – PCE, PCME, CE/P&D, CFTM, CE/P&D. In-order to implement GCT policy over DFCCIL, designations of DFCCIL officers to be considered equivalent to Railway officers as mentioned in the GCT Policy have been decided/approved by Competent Authority as specified in the following table:
