PROCEEDINGS OF THE VIGILANCE AWARENESS WEEK- 2019

As per the directions of CVC, Vigilance Awareness Week -2019 was observed in DFCCIL from 28th Oct, 2019 to 2nd Nov, 2019 throughout the organization. There are 14 field units in DFCCIL namely – Ambala , Meerut, Tundla , Allahabad(East) , Allahabad(West), Mugalsarai , Kolkata, Noida , Jaipur , Ajmer, Ahmedabad, Vadodara , Mumbai (North) & Mumbai(South). Various programs, events such as lectures/ seminars, SKIT, Quiz/ Essay writing/ slogan/ poster competition, Awareness Gram Sabhas, Grievance Redressal Camps etc. were organized in respective field units of DFCCIL including Corporate Office, New Delhi in order to create awareness and educate all stakeholders to fight against corruption which is precisely the purpose of VAW.

A. Programs and events organized at CO, New Delhi

1. Display Of Banners At prominent locations of the office

Banners depicting the theme of this year's VAW – 'Integrity- A Way Of Life' were displayed at prominent locations of the office.



Programs to be conducted during the VAW were also displayed on all the notice boards of the office. In addition to this, **bulk SMSes** were also sent to all the concerned officials of DFCCIL in order to generate awareness and educate them regarding the need to be self-vigilant. Approximately 5000 SMS es were sent to the officials of DFCCIL during the week.

2. Pledge Taking Ceremony :

Pledge taking ceremony was held on 28.10.2019 at CO, DFCCIL as per the guidelines of CVC. All the officials of DFCCIL including the outsource staff were present during the event. The Integrity pledge was administered to all the concerned officials by Sh. Anshuman Sharma, Director/PP/DFCCIL.

CVO/DFCCIL, Sh. Ashish Kumar, too, addressed the gathering and laid emphasis to the need of being vigilant in order to fight the corrupt practices. He also encouraged all the officials to participate in the events to be organized during VAW in large numbers so as to make the event a success. All the officials were encouraged to take E-pledge. All the field units were also instructed to ensure that all the officials as well as maximum no. of PMC and contractor staff undertake E-pledge.



3. Other Events During the VAW- 2019

- To spread awareness and to educate officials as well as public about the menace of corruption a **SKIT** was organized on 29.10.2019. The SKIT was performed by the members of Hansraj Dramatics Society, Hansraj College at the entry/ exit points of Pragati Maidan Metro Station and also within the premises of DFCCIL. The SKIT performing team comprised of 18 members. This unique initiative by DFCCIL was a great crowd puller.





- A **Quiz competition** was organized at CO, DFCCIL on 30.10.2019. The Quiz competition intended to create the awareness amongst the participants as well as enhance their knowledge regarding corruption related issues. A professional quiz master, Sh.Ajay Poonia was hired to conduct the quiz. Mr.Poonia has been hosting quizzes for over 7 years for several corporates, PSUs, colleges, TV channels etc. Total 06 teams (each team consisting of 03 members) participated in the competition. The teams securing first, second and third positions were awarded. Besides these, there were 15 questions for the Audience too. All the members of winning teams as well as 15 members from the audience were awarded suitably. All the participants performed with great zeal and the event was extremely successful and was well received in the organization.



- An **Essay competition** was organized amongst the officials and staff of DFCCIL at CO on 30.10.2019. A total of 18 officials participated in the essay competition.

All the winners of essay competition were suitably awarded.



- **Lectures and presentations** were organized all through the VAW- 2019 in order to generate awareness and educate the officials regarding vigilance related issues. A lecture on **“What is a Vigilant organization and how to make one”** was delivered by Sh.V.K. Saxena, Ex.CVO/PGCIL on 29.10.2019. The lecture session was attended by the 20 senior officials of DFCCIL including the Directors as well all the field units of DFCCIL via video conferencing. The session was highly interactive and quite fulfilling.



- A lecture and presentation was delivered by Sh.Ajay Rawat, DGM/Legal(GAIL) on the role of vigilance (preventive , punitive etc.) and other wide ranging issues related to vigilance on 31.10.2019. The session was attended by 40 officials from the field units. Another

lecture was delivered by Sh. Sanjay Khuranna, PPS/PED/Rly Brd.(31.10.2019) on vigilance set up in Railway and DFCCIL and the mechanism of functioning of the vigilance department attended by 40 officials from field units. Both these lectures were interactive in nature and were highly educative in nature.





- Another lecture on Conduct Rules was delivered on 31.10.2019 by Sh.Mukesh Chaturvedi, Faculty, ISTM. The session was attended by 60 officials from field units as well as Corporate Office. The participants for the above three sessions were specifically chosen in the sense that all were young and are part of supervisory cadre as well as lower management so that they shall be sensitized and made aware about the relevant issues during the initial period of their service itself. The officials of the vigilance department, DFCCIL also interacted with the participants on wide ranging issues.



- A lecture and discussion on public procurement was taken by Sh.S.K. Srivastava, Supt Engg, CPWD(Former TE/CVC) on 01.11.2019. Other issues related to vigilance were also discussed during the session. The session was attended by 30 senior officials of DFCCIL. MD/DFCCIL, Sh. Anurag Sachan also attended the session and shared his views on the vigilance culture of DFCCIL. All the field units of DFCCIL(14 in No.) also attended the session via video conferencing. The session was highly interactive and fruitful.



- The session was followed by unveiling of **Vigilance Bulletin- 2019** by MD/DFCCIL (01.11.2019). The Vigilance Bulletin is highly educative and contains case studies, relevant articles by employees of DFCCIL etc. It also contains the messages from Honourable CVC, MD/DFCCIL & CVO/DFCCIL that encourages all of us to be vigilant and follow probity in our public life.



- In addition to these, various programs were also organized in the field units of DFCCIL such as conduct of Workshop/sensitization programme, distribution of Pamphlets/Banners, organizing Grievance Redressal camps, essay and debate competitions etc.
