VAW-2020

Vigilance Awareness Week -2020 was observed in DFCCIL from 27th October to 2nd November, 2020 with the theme "सतर्क भारत ,समृद्ध भारत - Satark Bharat, Samriddh Bharat (Vigilant India, Prosperous India)." A number of steps were undertaken by DFCCIL Vigilance for awareness generation as well to educate the officials regarding issues related to Vigilance etc. Highlights of VAW-2020 are as given below:

- All the employees were informed to take Integrity Pledge preferably via online mode. Moreover, all the contractors, vendors and other concerned were also encouraged to take Integrity Pledge.
- 2. Sh. S P Singh, Director, Central Vigilance Commission was invited for a presentation/interaction session with the senior officials of DFCCIL on 02.11.2020. Sh. Singh gave an illuminating talk on Procurement and Preventive Vigilance Actions with practical examples to senior DFC officials at the Corporate office as well as 14 Field Units who joined through Video Conferencing. Sh.S P Singh explained various facets of Public Procurement in Public Sector. He further laid emphasis on Preventive Vigilance measures and its effectiveness. Identification of Risk areas and approaches to combat Corruption were further explained. The session was widely appreciated in view of knowledge enhancements.
- 3. DFCCIL, Vigilance also invited Sh. Ajit Mishra, Director/ Institute of Economic Growth, Delhi for a lecture/presentation session on 02.11.2020. Sh. Mishra talked about "Corruption, Trust and Governance" and discussed the recent trends regarding corruption. He also took the participants through various Economic Researches regarding Corruption. The session was attended by senior most officials of DFCCIL including MD/DFCCIL, Directors, and CVO etc.

- 4. DFCCIL Vigilance also conducted an Essay Competition on the theme of VAW-2020 during the week for awareness generation as well as for the involvement. Moreover, posters and banners were also displayed throughout the offices for awareness generation. Badges on the theme of VAW, were also distributed amongst the employees of DFCCIL including the outsource staff.
- 5. CVO/DFCCIL, Dy.CVO and other nominated officials also participated in the NATIONAL CONFERENCE ON VIGILANCE & ANTI-CORRUPTION from 27th to 29th October, 2020, organized by CBI via Virtual Platform.
- 6. Social media platforms, such as Wts App, Facebook, Twitter were also used for awareness generation as well as updating the activities undertaken during the week.
- 7. All the field units of DFCCIL participated in the VAW-2020. Various events as well as outreach activities were organized for DFCCIL officials as well as Contractor's officials, PMC official's etc. such as workshops, seminars and lectures, sensitization programs, conducting competitions (essay competition, quiz competition, debates etc.) in schools and colleges. Grievance redressal meetings/camps for officials as well as Contractors and Vendors were also organized in some of the field units. Moreover, dissemination of Anti-Corruption message and awareness programmes were organized in Gram Sabhas and Gram Panchayats in Ahmedabad and Meerut field units of DFCCIL.
