

Brief Details of observing 'Vigilance Awareness Week (VAW)-2024' in DFCCIL

A. The Central Vigilance Commission (CVC) directed to observe a 3-month Preventive Vigilance campaign from August 16 to November 15, 2024, focusing on five key areas viz. (a) Capacity Building programs (b) Identification and implementation of Systemic Improvement measures (c) Up-dation of Circulars/Guidelines/Manuals (d) Disposal of complaints received before 30.06.24 and (e) Dynamic Digital Presence.

B. The Vigilance Awareness Week (VAW)-2024 was observed in DFCCIL from 28.10.2024 to 03.11.2024 on the theme “सत्यनिष्ठ की संस्कृति से राष्ट्र की समृद्धि: Culture of Integrity for Nation's Prosperity.”

Steps undertaken by DFCCIL Vigilance for awareness generation during VAW-2024 are summarized as under: -

1. **An interactive session on “Security aspects in Digital space”** was conducted by Shri Anish Prasad, *IPS*, ED/Vigilance (Police)/ Rly Board on October 25, 2024, at the DFCCIL Corporate Office in New Delhi. Approximately 250 officials from 14 Field Units and the Corporate Office participated in the session, both online and offline.
2. **Pledge-taking ceremony** was held at 11:00 AM on October 28, 2024. The MD/DFCCIL administered the pledge to officials at the Corporate Office, while Unit Heads (CGMs) did so at 14 Field Units. DFCCIL employees, contractors, vendors, and other stakeholders were also encouraged to take the Integrity Pledge. Approximately 738 officials, staff, and others within DFCCIL took the Integrity Pledge online.
3. **A Signature campaign** was conducted at the Corporate Office and 14 Field Units of DFCCIL on October 28, 2024. The MD, Directors, and CVO initiated the campaign by signing an Integrity Pledge on signature flex. Subsequently, other officials also signed on signature flex. Approximately 800 DFCCIL officials participated in the signature campaign.
4. **A Selfie Point** featuring an Integrity Pledge and a train engine was set up. DFCCIL officers, staff, and visitors enthusiastically took photographs at the Selfie Point from October 28 to November 3, 2024.
5. **A Slogan writing competition** was organized as part of Vigilance Awareness Week (VAW). Ninety-eight officials, including field unit staff and outsourced personnel, participated in the competition. The three best slogans were awarded prizes, and ten additional slogans were printed on attractive posters and displayed at prominent locations in DFCCIL offices during the VAW.
6. **A Quiz Competition** focused on anti-corruption, DFCCIL, general awareness, and vigilance-related topics was held at the Corporate Office on October 29, 2024. Six teams, each comprising three staff members, participated in the competition. The winning team, which included a female member, was awarded a trophy and commendation certificates by the MD/DFCCIL.

7. **A Movie themed around corruption** was screened on October 30, 2024, for DFCCIL officials and staff at the New Delhi office and all 14 Field Units. The movie, which highlighted relevant corruption issues, was impactful in raising awareness. **A Quiz Session** based on the movie was conducted immediately afterward, with cash prizes awarded on the spot for correct answers.
8. **An Interactive Session on “Ethics and Governance”** was conducted by Shri Ghansam Bansal, Dean, Delhi Metro Rail Academy, on October 30, 2024, at the DFCCIL Corporate Office. Approximately 225 officials from 14 Field Units and the Corporate Office participated in the session, both online and offline.
9. **A Vigilance Journal titled ‘Sanchetna’** was unveiled on November 1, 2024, by the MD/DFCCIL, CVO, and other senior DFCCIL officials. The journal’s design, concept, and content, particularly the case studies, have been widely appreciated within DFCCIL. As intended, the journal will serve as a valuable tool for raising awareness and sharing information.

10. Besides the above, DFCCIL effectively utilized **Social Media platforms** like WhatsApp, Facebook, LinkedIn, and Twitter to promote anti-corruption and integrity. Three custom short videos focused on anti-corruption, integrity, and honesty were shared via WhatsApp groups within DFCCIL during the week. Additionally, daily updates on VAW-2024 activities were regularly posted on all social media platforms.
 11. All DFCCIL field units actively participated in VAW-2024 with great enthusiasm. Various events, including **pamphlet distribution, quiz competitions, essay writing competitions, slogan writing competitions, street plays (Nukkad Natak), lectures, and a walkathon** in Kolkata, were organized at field units and in local schools, colleges, and universities. Sensitization workshops were conducted in Ambala, Vadodara, and Kolkata field units. Field units also organized events and competitions in schools and colleges. **Grievance redressal camps** were held for outsourced staff, security personnel, and contractors working under Vadodara and Kolkata field units. Additionally, field unit officials participated in **lectures, discussions, and other competitions** organized by DFCCIL Vigilance. **Awareness Gram Sabhas** were conducted in Prayagraj, Ambala, Kolkata, and Mumbai field units.
- C. The observance of Vigilance Awareness Week 2024 in DFCCIL was highly successful and met its intended objectives.

I, therefore, pledge:

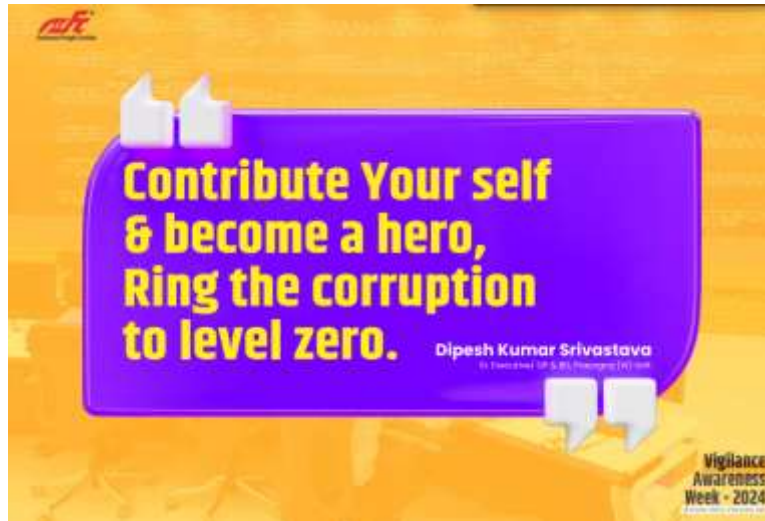
- To follow probity and rule of law in all walks of life;

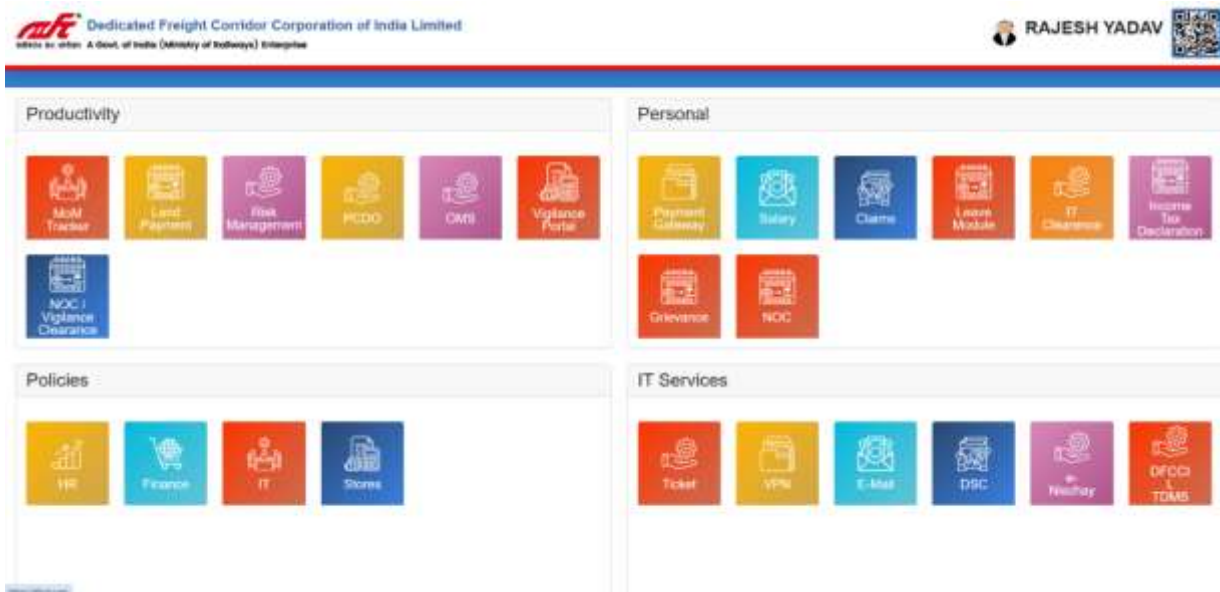
