Sub: Working and Business hours of DFCCIL stations handling with goods traffic.

Commercial rules of Indian Railways will be applicable on DFCCIL mutatis mutandis like a Zonal Railway as per Railway Board's letter under reference (2) above. The competent Authority vide BD circular No. 03 of 2023 dated 23.02.2023 has decided that the Working and Business hours of DFCCIL stations handling with goods traffic will be 06.00 to 22.00 Hrs. as per para 4.1 of Railway Board Circular under reference (1) above except those goods shed which will be notified separately.

In terms of letter under reference (3) above, the Competent Authority has now decided to notify 'round the clock working hours of New Kalanour (KNZN) Goods Shed of EDFC' from the date of issue of this letter.
