Expression of Interest (EOI) For Development of Gati Shakti Multi-Model Cargo Terminals (GCTs) on Non-Railway Land (Schedule - '1') and Railway Land (Schedule - '2') of GCT policy issued by Railway Board.

1. ABOUT DFCCIL

The Dedicated Freight Corridor Corporation of India Limited (DFCCIL) is a Special Purpose Vehicle established in October 2006 under the Ministry of Railways, with the mandate to develop, construct, operate, and maintain India's Dedicated Freight Corridors (DFCs). Incorporated under the Indian Companies Act of 1656, DFCCIL aims to enhance the country's freight services by running high-axle-load trains at speeds up to 100 kmph and developing freight terminals for efficient cargo handling through Private participation under Gati Shakti Policy issued by Railway Board. The status of the Dedicated Freight Corridor Corporation of India Limited (DFCCIL) projects is as follows:

- **Eastern Corridor**: This corridor, which spans approximately 1,337 kilometers from Ludhiana to Sonnagar, is fully commissioned. It primarily serves the coal, steel, and heavy industries in the eastern region, connecting them to the northern hinterlands.
- Western Corridor: This corridor, running approximately 1,506 kilometers from Dadri to Jawaharlal Nehru Port (JNPT), is 93.2% complete. It passes through key industrial states like Haryana, Rajasthan, Gujarat, and Maharashtra.

Both corridors are designed to enhance freight transportation by running high-axle-load trains at speeds up to 100 kmph, thus decongesting the existing rail network and improving the efficiency, safety, and reliability of goods movement across India.

These corridors, designed to separate freight from passenger traffic, are expected to decongest the Indian Railways network, improve transportation efficiency, and reduce carbon emissions. Current Status of GCTs on DFCCIL

DFCCIL is expanding its network by integrating various rail connectivity projects. This initiative, which incorporates contributions from the National Industrial Corridor Development Corporation (NICDC) and the Container Corporation of India Limited (CONCOR), ensures a unified and efficient infrastructure.

GCTs under Schedule- 2'

Request for Proposals for various locations have been floated by DFCCIL and after a competitive tendering process, Letters of Award (LoA) were granted to the lowest bidders for the development of GCTs at New Rewari, New Bhaupur, New Saradhana, New Gothangam, New Daudkhan, New Sakhun, New Dabla and New Gulaothi.

GCTs under Schedule- '1'

GCTs under Schedule- '1' of the GCT Policy, located on private land, are being developed in New Sanjali, New Rewari, New Malikpur, New Dadri, New Dabla, and New Dharuhera, further expanding the network and reinforcing the commitment to transforming India's freight logistics landscape

2. About EOI

DFCCIL intends to invite expression of interest, from the parties meeting the eligibility criteria as per the GCT Policy issued by Railway Board, for (a) Development of Gati Shakti Multi-Modal Cargo (GCT) Terminals on Entirely/ Partially on Railway Land under Schedule - '2' of the GCT Policy and (b) for Development of Gati Shakti Multi-Modal Cargo (GCT) Terminals entirely on Non-Railway Land under Schedule - '1' of the GCT Policy, to enhance logistics infrastructure, reduce overall supply chain costs, and boost modal share of railways in freight transport.

Through this EOI, DFCCIL aims to attract private investment to develop these terminals, which will leverage the modern, high-capacity rail connectivity of the DFCs. Interested applicants, such as logistics service providers, manufacturers, and warehousing investors, are invited to express their interest by submitting proposals that detail their plans for terminal development, including projected traffic, infrastructure requirements, and business strategies.

Interested firms should submit expression of interest in case of freight terminal on railway land under Schedule-'2' of GCT Policy and a formal application in case of freight terminal entirely on private land under Schedule- '1' of the GCT Policy using the formats provided in Appendix - I and II (as applicable) along with Appendix - III and, ensuring that all responses are submitted by 24:00 hrs on the specified date at the place described in the EOI document. 3. Who are eligible to set up GCTs

- **3.1** The following category of applicants are permitted to set up GCTs, as GCTO, as per GCT Policy issued by the Railway Board shall be as under:
 - a. Individual / Sole Proprietorship Firms
 - b. Hindu Undivided Family (HUF)
 - c. Partnership Firm
 - d. Company Registered Under Companies Act 2013
 - e. Limited Liability Partnership (LLP)
 - f. Registered Society/ Registered Trust
 - g. Joint Venture (JV)/ Consortium

3.2 Government / semi-government agencies and statutory bodies under central/State govt. (including Development Authorities and municipal bodies) shall also function as GCTO, to set-up Cargo Terminals(s).

4. <u>Salient Features of GCT Policy:</u>

The GCT policy includes several features to facilitate its implementation:

- <u>Simplified Processes:</u> A streamlined process for approvals ensuring quick and hassle- free approvals.
- <u>Cost and Fee Structures:</u> Railway shall not levy any *departmental charges for supervision, inspection and related activities, for the construction of GCT.*
- <u>Commercial staff cost:</u> No cost of commercial staff will be charged by GCTO.
- Land License Fee: The policy allows low land license fee for leasing railway land for cargo facilities, charging 1.5% of market value of land per annum with annual escalation of 6%. It has been substantially reduced from the earlier 6% per annum of the market rate of land in the earlier policies. This will help businesses to gain good ROI.
- <u>Handling rights:</u> GCTO will have exclusive handling rights for which handling charges/ fee, as decided by the GCTO as per good industry practices, may be charged.
- <u>Claim on Terminal Charge (TC)/ Terminal Access Charge (TAC)</u>: Terminal developer stands to get a part of TC/TAC for the terminal as per the rates quoted by the terminal developer at the time of bidding.
- <u>Common user facility:</u> The capital cost for all common-user traffic facilities at the serving station, including Signaling Telecommunication works, modification and up-gradation to existing interlocking/ OHE, or electrification in future within the station limit up to take-off point, shall be borne by the Railway.
- <u>Minimum Infrastructure:</u> GCTs along the corridors of DFCCIL are low-cost terminals with an average cost of Rs. 10-15 crores, having one handling line and wharf of approx. 750x25m.

5. <u>Procedure for submission of Expression of interest under Schedule 2 of GCT Policy-Application under</u> <u>Schedule 1 of GCT Policy</u>

- 5.1 Expression of Interest for Development of Gat Shakti Cargo Terminals along Dedicated Freight Corridors Entirely/Partially on Railway Land under Schedule '2' of GCT policy.
 - Interested firms fulfilling the eligibility criteria for setting up GCTs Entirely/Partially on Railway land may submit their expression of interest along with their preferred locations across the stations of the two corridors, specified in the Annexure.
 - The Proposals may be sent through email or as hard copy (details mentioned in Para 5.3) along with duly filled Format mentioned as Appendix II and Appendix III.
 - The locations for which EOIs are received for Development of GCT on Entirely/Partially Railway land, an operational-cum-Technical feasibility shall be done by DFCCIL

officials. The size of land parcel to be offered for setting-up of GCT shall be decided by DFCCIL.

- DFCCIL will identify/determine the minimum infrastructure facilities required at the Terminal based on expected traffic.
- Based on EOIs and operational-cum-Technical feasibility report, DFCCIL may, at its discretion, issue a Request for Proposal (RFP) for open bidding for the identified locations.
- Tender will be invited on the IREPS work module and communicate to all participants.
- A two-packet single-stage tendering system shall be adopted. In the first packet, bidders will be evaluated on the following criteria:
 - Whether the bidder fulfils the minimum eligibility conditions, as stipulated in para 3 of Schedule 2 of GCT Policy.
 - Whether the proposed plan (of GCT) fulfills the minimum infrastructural facilities decided by the Division (which shall be clearly defined by the DFCCIL while inviting tenders).
- All the bidders who fulfill the above criteria shall qualify for the opening of the second packet financial bid.
- Bidders will be required to quote the percentage of Terminal Charges and Terminal Access Charges to be retained by the Railway for all the traffic handled at the Terminal. An eligible bidder quoting the maximum share of Terminal Charges and Terminal Access Charges to the Railways will be awarded the contract.

5.2 Application under Schedule '1' of GCT policy and Location Choice:

- Applicants interested in developing a GCT entirely on Non-Railway land along the Eastern or Western dedicated freight corridors, at preferred locations specified in the Annexure (enclosed) may submit the application to DFCCIL as per the prescribed format.
- The applicant shall be required to submit application along with Application Fee (non- refundable) of Rupees Twenty Thousand (Rs. 20,000/-) only plus GST, as applicable. The on-line application shall essentially contain the following details:
 - Details of the applicant- Name and designation of the authorized personal, along with the details mentioned in GCT policy.
 - Concept plan, duly indicating the location and sketch of the proposed Terminal and proposed connectivity with the serving station.
 - Traffic projection (including commodities, expected volume per year, expected number of rakes per year, and types of stock to be handled.
