Consultancy Services : Engagement of NGOs for Implementing Resettlement Action Plan (RAP) for Bhaupur – Khurja Section APL-1 (343 Kms.)

1. Government of India has applied for loan assistance for construction of Eastern Dedicated Freight Corridor (EDFC). As a part of details engineering studies, a Resettlement Action Plan has been prepared and disclosed on the DFCCIL website (<http://www.dfccil.org>). The RAP envisages services of an experienced Non-Governmental Organisation (NGOs) to facilitated implementing the Resettlement Action Plan (RAP) on this project. For the purpose DFCCIL invites Expression of Interest (EOI) from eligible NGOs to carry out the assignment.

2. The NGO will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers January 2011.

3. The following are the eligibility criteria for selection.

a) Must have been a registered and reputed NGO/Trust/Non-Profit Company with at least 15 years of experience in the development field with demonstrable skills in the areas of community mobilization, IEC, livelihoods and income generation, governance and social accountability, women empowerment, and resettlement and rehabilitation.

b) It must have 3 (three) R&R specialists with a minimum of 5 years of work experience with excellent skills in writing and speaking English and must be conversant in Hindi.

c) It must have experience of having implemented projects directly funded by reputed international agencies/NGOs.

d) Its average annual turnover for the last three years must be equal to or more than 150% of the proposed budget for this activity.

e) It must have operating field office in the state of Uttar Pradesh.

4. The applications should be supported by the attested/verified copies with the following details.

i) Organization structure including the details of experts and support personnel with their relevant qualification and experience with the Organization.

ii) Details of the work done (volume/cost, nature, etc.) in the areas of R&R works for the last ten years, if not completed, percentage of work completed so far and likely date of completion)

iii) Experience in handling community organization and rural development works.

iv) Experience of handling R&R issues of Railway/Highways related works and any other projects having linear pattern settlement like road/highways, irrigation canals etc., along with the methodologies followed therein.

v) Any other details applicable to implementation of R&R in Railways/Highways related work, if not covered above.

5. Short-listing will be done on proven merit of the NGOs. The Technical and Financial proposals will be invited from the short-listed NGOs.
