Please refer the above Invitation for Pre-qualification which was published in all leading national newspapers on 18.11.2011, following Amendment/corrigendum is being issued. **The key modifications made in the PQ Application document are as under:**

**1. Section – II PDS – ITA – 17.1 should be read as :**

**Deadline of Submission of PQ Application** : Upto 1500 hrs. of 16.1.2012  
**Date of Opening of PQ Application** : 1530 hrs. of 16.1.2012

**2. Section – I ITA Clause 25.2 should be read as :**

*“Only the qualifications of subcontractors that have been identified in the application may be considered in the evaluation of an Applicant. However, the general experience and financial resources of subcontractors **will not be** added to those of the Applicant for purposes of prequalification of the Applicant.”*

**3. Section – I ITA - Clause 4.2 Eligible Applicant should be read as :**

*“The eligibility criteria listed in this Clause 4 shall apply to the Applicant, including the parties constituting the Applicant, i.e. its proposed partners, subcontractors for any part of the Contract including related services.”*

**4. Section – II PDS Clause ITA 4.1 para xiii) (k)(i) should be read as :**

(i) *Notary certified copy of resolutions of the Directors of the Company, permitting the company to enter into **JV agreement, authorizing MD or one of the Directors or Managers** of the Company to sign JV Agreement, such other documents required to be signed on behalf of the Company and enter into liability against the company and/or do any other act on behalf of the company.”*

**5. Section – II PDS Clause ITA 9.2 should be read as :**

*“The interested applicant may purchase the PQ document from the address given in PDS Para 7.1 between 1000 hrs to 1700 hrs. on all working days **from 18.11.2011 to 13.1.2012** on payment of non-refundable cost of Rs.10,000/- in the form of DD/Banker's Cheque issued by SBI or any other nationalized bank or schedule bank of India in favour of Dedicated Freight Corridor Corporation of India Ltd., Payable at Delhi/New Delhi. Prequalification document requested by Post will be dispatched by Registered/Speed post/Courier on payment of an extra amount of Rs. 500/- (Rs. Five Hundred only). **DFCCIL will not be held** responsible for postal delay if any, in the delivery of the PQ document or non-receipt of the same. Alternatively prospective applicant can download the PQ*

document from DFCCIL website ([www.dfccil.org](http://www.dfccil.org)) or ([www.dfcc.in](http://www.dfcc.in)) . In case of downloaded application an account payee DD/Banker's Cheque issued by SBI or any other nationalized bank or schedule bank of India amounting to Rs. 10,000/- in favour of Dedicated Freight Corridor Corporation of India Ltd., Payable at Delhi/New Delhi has to be attached with the PQ application.

The PQ application form can be purchased in the name of any constituent member but submitted only in the name of the JV Firm.”
