This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in United Nations Development Business on-line of 08 February, 2010 and in DG Market.

The Government of India, Ministry of Railways *has received loan for Eastern DFC Project – I* from the World Bank toward the cost of *Eastern DFC Project – I* and intends to apply part of the proceeds toward payments under the contract for Design, Construction, Supply, Installation, Testing & Commissioning of 2x25 KV Electrification, Signaling and Telecommunication and associated works of double-track railway lines under construction on a design-build lump sum basis for Bhaupur – Khurja section of Eastern Dedicated Freight Corridor. The Dedicated Freight Corridor Corporation of India Ltd. intends to prequalify contractors and/or firms for contract package 104 as per details given above. It is expected that invitations to bid will be made in **December, 2012**.

Prequalification will be conducted through the procedures as specified in the World Bank's [*Guidelines: Procurement under IBRD Loans and IDA Credits*](#), January 2011 and is open to all eligible bidders as defined in the guidelines.

Interested eligible bidders may obtain further information, and inspect the prequalification documents, from the office of Dedicated Freight Corridor Corporation of India Ltd. at the address below during office hours, *i.e. 0930 to 1800 hours*. A complete set of prequalification documents in English may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a nonrefundable fee of Rs. 10000/- or US\$ 200. The method of payment will be through demand draft or Banker's cheque drawn in favor of Dedicated Freight Corridor Corporation of India Limited, payable at New Delhi. The pre-qualification document can be obtained from the office of DFCC in person during 1100 hrs to 1700 hrs. on any working day. If the applicant desires the document be sent by post/courier service, then an additional charge of Rs. 1000/- for inland delivery and Rs. 5000/- or US\$ 100 for overseas delivery shall also be paid along with

the fee stated above. The request for sending pre-qualification application by post/courier service must be received in the office of DFCC with requisite fee before **22.08.2012**. The pre-qualification document can also be downloaded from DFCC website www.dfcc.in. If the document is downloaded from website the applicant must deposit the non-refundable fee of Rs. 10000/- or US\$ 200 as stated above with the application, failing which the application shall be summarily rejected.
