4.4 An Applicant shall not have any conflict of interest with any other party involved with the project, either as an Applicant or in any other capacity during the project formulation and developmental stage. Any Applicant (s) including all members of the Joint Venture found to have a conflict of interest shall be disqualified. Applicant(s) shall be considered to have a conflict of interest,
<ul> <li>(i) if they participated as a consultant in the preparation of the design or technical specifications of the Works that are the subject of this prequalification.</li> </ul>
(ii) Where a firm, or a firm from the same economic or financial group, in addition to consulting, also has the capability to manufacture or supply goods or to construct works, that firm, or a firm from the same economic or financial group, cannot normally be a supplier of goods or works, if it provided consulting services for the contract corresponding to this prequalification, unless it can be demonstrated that there is not a significant degree of common ownership, influence or control.
4.5 An Applicant shall submit only one application in the same Prequalification process, either individually as an Applicant or as a partner of a joint venture. No Applicant can be a subcontractor while submitting an application individually or as a partner of a joint venture in the same Prequalification process. A Sub-contractor in any application may participate in more than one application, but only in that capacity. An Applicant who submits, or participates in, more than one application will cause all the applications in which the Applicant has participated to be disqualified.

	4.8 The Applicant shall be considered disqualified / in-eligible if:
	(a) The Applicant or any of its partners and/or subcontractors included in the application for pre- qualification has been banned for business with Ministry of Railways along with any of its attached and subordinate offices through an order issued by Ministry of Railways as per list available on Web site ( <u>http://www.indianrailways.gov.in/</u> <u>railwayboard</u> ) of Civil Engg Directorate of Railway Board pertaining to Banning of Business, with the Banning being valid as on the last date of submission the PQ Application.
	(b) The Applicant or any of its partners and/or sub- contractor included in the application for pre-qualification has suffered bankruptcy / insolvency or it is in the process of winding-up or there is a case of insolvency pending before any Court on the deadline of submission of Application.
	4.9 The Applicant / each partner of the joint venture including the proposed sub-contractors, shall submit an undertaking to this effect duly signed by their authorized signatory along with the Application for prequalification stating that they are not liable to be disqualified as per sub clause 4, using the appropriate Performa mutatis-mutandis given in Section IV. Non submission of such an affidavit by the Applicant shall result in summary rejection of his Application

# Project Information & Scope of Work in Brief

# 1. General

1.1 Dedicated Freight Corridor Corporation of India (DFCCIL) is a Special Purpose Vehicle set up under the administrative control of Ministry of Railways to undertake planning & development, mobilization of financial resources and construction, maintenance and operation of the Dedicated Freight Corridors. In the first phase, DFCCIL will be constructing two corridors – the Western DFC and Eastern DFC- spanning a total length of about 3300 route km. The Eastern Corridor, starting from Ludhiana in Punjab and pass through the states of Haryana, Uttar Pradesh, Bihar, Jharkhand and terminate at Dankuni in West Bengal. The Western Corridor will traverse the distance from Dadri to Mumbai, passing through the states of UP, Delhi, Haryana, Rajasthan, Gujarat and Maharashtra.

The route alignment of Freight Corridors is mostly parallel to existing adjacent Indian Railway Track. However alignment is on detour at some locations to avoid social/environmental/wild life impact.

The project entails construction of mostly double-track electrified railway lines. Sub Structure such as Bridges and embankment would be fit for 32.5 Tonne Axle load and Track structure would be designed for handling 25 Tonne axle load with train speed up to 100 Kmph.

The Eastern Corridor will handle single stack containers whereas Western Corridor is planned to cater to double stack containers. Up gradation of transportation technology, increase in productivity and reduction in unit transportation costs have been taken as guiding principles for freight corridor.

# 2.0 **Project Information :**

Proposed Important Bridge falls in this section of DFC alignment between Dehri-on-sone and Sonnagar Railway stations of Railways in the districts of Rohtas & Aurangabad of Bihar state. Indicative Bridge location is enclosed as Annexure – II.

2.1. DFCCIL intends to carry out the work of Design and Construction of Important Bridge across river Sone (approximate length 3.06 Kms), its approaches (on both sides) and other miscellaneous works for double track electrified railway line on Design Build Lump Sum Basis between Sonnagar (Rly.Km.549) and Dehri-on-Sone (Rly.Km.554) Railway Stations on Mughalsarai-Sonnagar Section of Eastern Dedicated Freight Corridor.

Bridge and its approaches are to be constructed for double line electrified track with 2 x 25 KV AC, 50 Hz, overhead catenary system, capable of operating at a maximum train speed of 100km/h. Formation and bridge structure are to be provided for 32.5 tonnes axle load.

The Contractor shall undertake the design, construction, manufacture, supply, installation, testing and commissioning of the Bridge Structure including associated approaches on both sides and other misc. works and without limitation, the design, construction and removal of any Temporary Works on Design Build lump sum basis. The bridge will be constructed on D/S (downstream) side of newly constructed Railway Bridge.

#### 4. Scope of work in brief :

#### 4.1 Bridge Works :

The bridge works shall comprise of but not limited to the design, construction, fabrication / manufacture, supply, installation, testing and commissioning of:

- a) Important Bridge across river Sone (approximate length 3.06 Kms), its approaches and other miscellaneous Works,
- b) Survey and investigation including geotechnical investigation including but not limited to setting out, benchmarking etc.,
- c) Construction of Bridge foundation & substructure, bearings, approaches on both sides in embankment/cutting, approach slabs, drainage and other miscellaneous works etc.
- d) PSC Bridge superstructure consisting of construction and launching of PSC Super Structure including trolley refuge and support for OHE posts, etc.
- e) All the temporary works as required for construction of foundations/substructure and launching of PSC superstructure across the river, etc.
- f) All testing and commissioning activities,
- g) Any other activity connected with the construction and commissioning of the bridges,
- h) The scope of work does not include any track work

#### 4.3 **Testing Commissioning and Interfacing :**

Contractor will have to take the overall responsibility for the testing and commissioning of his work and all interfacing issues with other contractors deployed by the Employer on the project.

#### 5. **Project Implementation**

- 5.1 The Project involves Construction of Bridge followed by Testing and Commissioning and maintaining the constructed Railway Bridge during the defect liability period as mentioned in Bid Document.
- 5.1.1 The **Construction Period shall be 42 months** (including Design Period) from the date of award of the contract(s). The Design-Build Contractor shall be required to plan the various components of work in such a sequence that the complete work is constructed in above period from the date of award of contract. This will be followed by the **Defect Liability Period as specified in the Bidding document.**
- 5.2 CPM/Dy.CPM/DFCCIL will be the Engineer for the Project. Alternatively DFCCIL may appoint the Engineer.
- 5.3 As a part of the Bid Documents, the Pre-qualified Bidders will be provided with Employers Requirements, Concept Design, Performance Specifications and the other available field data e.g. Alignment.
- 5.4 The Employer's Requirements/Performance Specifications provided as a part of the Bid Documents, specify the procedural requirements for the preparation of the design of the Bridge and Temporary Works.

#### 6.0 Site and Other Data:

#### 6.1 Access to Site:

Access to the Site areas is available through various roads as described below.

- Transportation by road is well developed in Eastern area of India.
- Railway transportation is also well developed in this area.
- Cargos can be transported from Mumbai or Kolkata seaport.

- Airports are located at Delhi, Lucknow, Varanasi, Patna.
- Public telephone facilities are well developed in the project area.
- Mobile phones are also well developed in the project area.
- Internet access is available in the whole country of India with wire or wireless. Connection speed is depending on service providers.
- **6.2 Project Area:** The Works will be carried out between Dehri-on-sone and Sonnagar. The proposed Bridge alignment will mostly be parallel to the Bridge alignment of Indian Railways .

A sketch showing the alignment is attached as Annexure 1.

**6.3 Climate:** The climate of the project is a Tropical Monsoon Climate Marked by three distinct seasons:

**Summer** (march-June): Hot & dry with average temperatures of  $45^{\circ}$ C sometimes reaching 47-48°C with low relative humidity (20%) and dust laden winds.


**Monsoon** (June-September): 85% of the average annual rainfall of 990 mm precipitates during this period and temperatures range from 40-45 °C on rainy days.

**Winter** (October-February): Cold with temperatures in the range of  $3-4^{\circ}C$  sometimes dropping below freezing in elevated areas. Foggy conditions can occur in some tracts.


#### 6.4 Medical Facilities
