1	Section – III	1.0 (3) General	<p>The Clause 1.0 (3) General Section – III (pg. 23) is amended as follows :</p> <p>Applicants while identifying the proposed specialist sub-contractors shall suggest name of only one sub-contractor instead of multiple sub-contractors for similar activity.</p> <p>If the Applicant proposes to change the sub-contractor for Bridge design at Bid Stage from the sub-contractor for Bridge design proposed in the PQ stage, they must seek specific approval from DFCCIL. The proposed sub-contractor must meet the qualifying criteria laid down in the PQ Document. The applicant shall submit the credentials of the proposed Designer with the Bid for evaluation.</p>
