11. Information of the item is as under:-

- (i) The work of "Design and construction of civil, structures and track works for double line railway involving formation in embankments/cuttings, ballast on formation, track works, bridges, structures, buildings including testing and commissioning on design – built lump sum basis for Bhaupur – Khurja section of Eastern Dedicated Freight Corridor – Contract package: Lot-101, 102 & 103" was awarded to M/s Tata-Aldesa (JV) vide contract agreement no. HQ/EN/DB/Bhaupur-Khurja/Lot-101, 102 & 103 respectively.
- (ii) As per clause 4.2 section VI part-2 volume 4 (Design Criteria and specifications), all the Rails to laid in the track structure shall be UIC 60 flat bottom A class Rails as per specifications IRS T12-2009 of 880 grade.

- (iii) Accordingly, D&B Contractor M/s Tata-Aldesa (JV) has placed 3 purchase order to M/s Jindal Steel and Power Ltd., Jindal Centre, 12 Bhikaji Cama Place, New for procurement of Rails as per specifications for Three Lots after approval from the Engineer i.e. M/s SAI-TYPSA(JV). The copy of purchase orders is available in this office in the 3 sets of 5 pages each (Total 15 pages) and can be obtained after realisation of due charges, i.e. Rs.30/- (Rs.2/- per page).
- (iv) Further on the request of M/s Jindal Steel and Power Ltd., New Delhi, M/s RITES Ltd. submitted their offer for carrying out inspection activities of Rails at JSPL, Raigarh, Chhatisgarh of required quantity strictly as per IRS-T-12-2009 and Flush Butt Welding Manual. This information in documents containing 2 pages, is available in this office, can be obtained after realisation of due charges i.e. Rs.4/- (Rs.2/- per page).
- (v) In reply of the offer of M/s RITES, M/s JSPL has issued a contract for carrying out inspection activities of Rails at JSPL, Raigarh vide their letter dated 31.03.2014. This information in documents containing 2 pages, is available in this office, can be obtained after realisation of due charges i.e. Rs.4/-(Rs.2/- per page).
- (vi) As per clause 4.2.3 (d), the manufacturing process of Rails shall be offered to inspecting agency at the beginning and intervals as desired by such inspecting agency, to conduct the required test for qualifying criteria to be satisfied.
