 project Management" for monitoring of DFC project from Durgauti (District-Kaimur, Bihar) to Sasaram (District-Rohtas, Bihar) approx 56 km
 under Chief Project Manager/DFCCIL/Mughalsari.
- 2. Scope of Work- Drone Aerial Videography of EDFC track of DFCCIL from Durgauti (District- Kaimur, Bihar) to Sasaram (District- Rohtas, Bihar) with the use of Drone. The scope of work include Drone Videography of DFCC track with adjacent IR track and other details along the alignment from SSM station to Durgauti Station of ECR/MGS division with labeling of details along the alignment, lattitude and longitude etc and submission of digital data/digital image/Video in CDs to CPM/DFCCIL/MGS.
- The drone Videography shall be limited to the strip of Railway land/land under acquisition and shall be taken through Drone in Indian Civil Airspace above the Railway land.
- 4. The agency/Firm shall have the required security clearance and certificates from the govt authorities for thus purpose. If any clearance/permission is required for the location to bevideographed, DFCCIL will facilitate the

permission of concerned authority for Drone Photography on request of the agency and will inform the authorities concerned in this regard. However the permission will be taken by the agency from authorities concerned.

- 5. Digital Data/Digital image of Drone Videography should be submitted in CD in Five copies for the official use of DFCCIL (PSU under Ministry of Railways). Copy of the same should neither be given by the agency to any third party, whatsoever for any purpose nor should retain by them to avoid any possible misuse.
- The CDs should be properly labeled with name of section, date etc. in proper CD cover.
- 7. All transport arrangement, Drone camera and necessary equipments for Drone- Videography should be arranged by the agency/firm.
- 8. Rates for the complete job will be per Km basis and should be quoted by the firm/agency in the bill of quantity. The payment will be made as per accepted rate by the competent Authority.
- Rates are inclusive of all taxes, duties etc and no extra payment will be made for any associated activity and payment will be made for total km of length of section videographed at the accepted rate only.

- 10. The <u>measurement</u> of the distance for the payment purpose will be linear distance along EDFC track.

- 12. Security deposit will be @ 5% of the cost of work.
