After carefull consideration of your appeal, on the above noted subject, the facts as enumerated, are as under:-

You have sought information in connection with land award and disbursement of amount to PAP of village Moti Dau, District Mehsana. Since, the information was relevant with the office of the Competent Authority Mehsana, as such, CPM/Ahmedabad transferred the matter to them vide letter no. DFC/ADI/CA/RTI/032 dt. 04.09.2014 and copy docketed to you and The letter no. J.S./Railway disposed off your intial application. Corridor/Camp/772/14 issued by the Competent Authority is enclosed as Annexure-A, for your ready reference.

Further, in response to your 1st appeal, on the basis of various detail of CPM/Ahmedabad's office and Competent Authority, Mehsana, parawise remarks to the issues raised, are as under:-

1) The land award copy of Mehsana District Moti Dau Village received in this office on 14.08.2013(Copy of the letter attached as Annexure-B).

2) Bank statement (5 Pages) of SLAO Mehsana for the F.Y.2013 is attached as

Annexure-C.

3) In accordance with the instructions contained in DoPT's letter No. 1/7/2009-IR dt. 1.06.2009 on RTI Act, "The definition of information cannot include within its fold answers to the question "why" which would be same thing as asking the reason for a justification for a particular thing. The public information authorities cannot expect to communicate to the citizen the reason why a certain thing was done or nor done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information."

In case, you are not satisfied with the information provided, you may inspect the relevant records pertaining to your RTI application dt. 30.09.2014, in DFCCIL Ahmedabad office on any working day, during office hours and obtain photocopies of the same after paying the due RTI Fee.

In light of the forgoing, your 1st appeal is disposed off.
