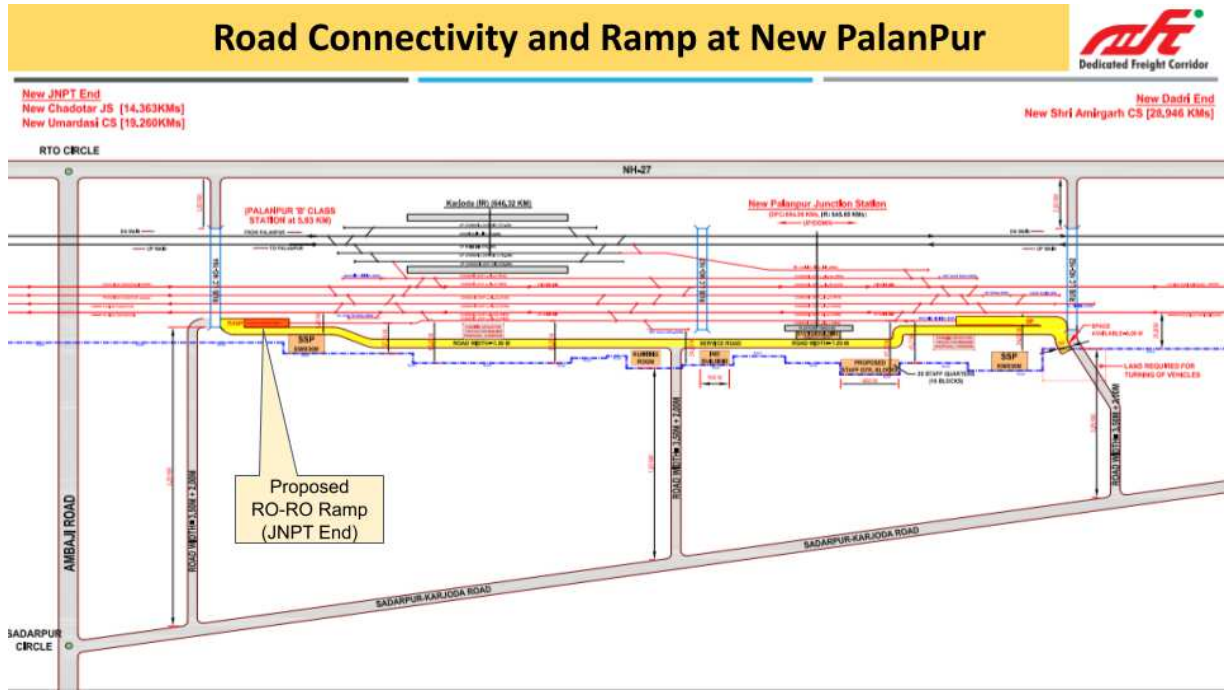

During Trial Run Period, no penal provision will be applicable except in case of willful default by the licensee the DFCCIL decision, in this regard, shall be final and binding on the Licensee. The only exceptions mentioned in the clause will be relaxed during the trial period.
