Dedicated Freight Corridor Corporation of India (DFCCIL), is a schedule 'A' Public Sector Undertaking under the administrative control of Government of India (Ministry of Railways). It is the most ambitious and biggest ever project in infrastructure sector, set-up to give economy a boost and build high capacity and high speed rail freight corridors along the golden quadrilateral and its diagonals. At present the Company has its Corporate Office at New Delhi and Field Units at Mumbai (South), Mumbai (North), Vadodara, Ahmedabad, Ajmer, Jaipur, NOIDA, Ambala, Allahabad (East), Allahabad (West), Meerut, Mughalsarai, Tundla and Kolkata.

2. The Company invites applications from retired employees from Govt. Central/PSUs on re-employment basis in Finance Department of DFCCIL in Corporate Office as well as in its Field Units for placing them on panel as per the eligibility criteria detailed below. 2.1 Maximum age should not be more than 63 years. Preference will be given to the retired employees below 62 years of age.
