Dedicated Freight Corridor Corporation of India (DFCCIL), is a schedule 'A' Public Sector Undertaking under the administrative control of Government of India (Ministry of Railways). It is the most ambitious and biggest ever project in infrastructure sector, set-up to give economy a boost and build high capacity and high speed rail freight corridors along the golden quadrilateral and its diagonals. At present the Company has its Corporate Office at New Delhi and Field Units at Mumbai, Vadodara, Ahmedabad, Ajmer, Jaipur, NOIDA, Ambala, Allahabad, Meerut, Mughalsarai, Tundla (Agra) and Kolkata.

2. The Company invites applications from retired employees from Govt./Central PSUs on re-employment basis in HR Department of DFCCIL for placing them on panel i.e. one post at each CPM Unit at Mumbai, Vadodara, Ahmedabad, Ajmer, Jaipur, NOIDA, Ambala, Allahabad, Mughalsarai and Tundla (Agra) as per the eligibility criteria detailed below.

2.1 Maximum age should not be more than 63 years. Preference will be given to the retired employees below 62 years of age and have experience from Indian Railways/Railway PSUs. Remuneration will be as per DFCCIL's Policy.

3. The shortlisted candidates will be called for personal interview and based on their performance they will be placed on the panel. They will be called as and when required keeping in view the requirements.
