By way of introduction, we are working P. Way contractors of Ambala Unit and other Zonal Railways of Indian Railways.

This is with regard to the subject mentioned work, wherein the called value of tender in the price schedule (enclosed as Annexure-1) uploaded on IREPS is Rs. 58,79,13,421.39/- However, the amount mentioned in the tender document is Rs. 58,87,23,421/-. Accordingly, there appears to be a difference of Rs. 8,09,999.61/-.

This is causing confusion to us while preparing for the bid. Therefore, your good self is humbly requested to please rectify this and issue a suitable corrigendum in this regard so that called tender value is clear. Since there are two values mentioned, the same is causing confusion and we are accordingly not in a position to bid for this work.

Given the above, a timely issue of corrigendum to this effect and rectifying the error will enable us to participate in the subject mentioned tender. Request you to please do the needful.
