Impact of Level Crossings on Safety and Operating Performance on DFCCIL

PCCIL is a special purpose vehicle set up by the Railway to plan construct and operate the dedicated freight corridor network. The alignment of freight corridor is largely parallel to existing lines so that segregation of freight and passenger traffic can be done and both streams of traffic can develop and provide improved transit. The average freight traffic speeds are expected to be 70 KMPH as against present average speed of 25 KMPH which will not only reduce transit time but also run scheduled freight services with customer focus.

While operationally dedicated freight corridor aims higher average speeds, higher axle load and long haul services it faces serious challenge due to large number of level xings along the route. There are 892 level xings on a length of 2750 Kms excluding Sonnagar – Dankuni section. The existence of level crossings has following hazards:

- The accident records of IR establish that maximum accidents take place on level crossings and consequent damages to train operations and the situation will get aggravated as number of lines and road traffic increase.
- Level xings pose a serious law and order challenges on railway train operation with 4-5 lines covered by existing lines and the gravity will further increase.
- Despite provision of double line and automatic signaling detention at about 10% of level xings could take place due to heavy road traffic or failures. It is estimated that time loss will be 7 to 8 minutes per LC. This translates to about 5 hours extra running time on Western Corridor having 464 LCs. On Khurja-Mughalsarai-Sonnagar Section of Eastern Corridor there are 217 level crossings which also would add about 3 hours extra running time.

Present policy of level crossings for IR and Dedicated Freight Corridor

One of the priority areas when DFCCIL reaches operational stage would be management of level crossings. After discussions with Railway Board few important decisions have been arrived at as following:

- There will be a common gateman for level crossings covering both IR and DFC tracks.
- 2. Efforts will be made jointly with adjoining Zonal Railways to replace level crossings with RUBs or Limited Height Subways wherever feasible.
- 3. Railway Board has further decided that level crossings having TVUs>50000 will be replaced with Road Over Bridge or Road under Bridge.

As per this policy on Western Corridor, it has been planned to build 306 RUBs and 89 ROBs and thus, eliminating 395 Level Crossings. Eastern Corridor has higher TVUs and with present yardstick, 148 ROBs and 4 RUBs on Sonnagar – Khurja Section are planned. The funding arrangements for these works are being tied up by Ministry of Railways.

Survey of Future Dedicated Freight Corridor Awarded to RITES

Indian Railways is one of the largest Rail network in the World connecting major Urban Centres of Delhi, Chennai, Kolkatta and Mumbai, known as "Golden quadrilateral and its diagonals". These corridors carry almost 65% of total freight traffic (International Railway Journal, 2003) and are over saturated. Hence drastic expansion of Railway transport capacity has become inevitable.

Indian Railways have already approved construction of two "Dedicated Freight Corridors (DFC's)" on Western and Eastern routes covering a length of 3373 kms. In view of serious line capacity constraints Railway Board has decided to undertake PET surveys of following future Dedicated Freight Corridors:-

- East-West Corridor (Kolkata Mumbai)
 2000 kms.
- North-South Corridor (Delhi Chennai)
 2173 kms.
- East-West Corridor (Kharagpur Vijayawada) 1100 kms.
- Southern Corridor (Chennai Goa) 890 kms.

DFCCIL has engaged M/s. RITES to conduct PETs survey of these future corridors at a cost of Rs.63.55 Crs. This work has started from September 2011 and shall be completed within 36 months. Depending upon the outcome of the study, future phases for DFC development will be decided by Ministry of Railways.

DFCCIL's CORPORATE SOCIAL RESPONSIBILITY POLICY

Corporate Social Responsibility (CSR) is the commitment by DFCCIL to improve the quality of life of the workforce and their families as well as of the local community and society at large. DFCCIL's CSR goes beyond charity and will integrate social, environmental and ethical concerns into the company's business processes. Generally the underprivileged and backward communities/areas where DFCCIL has its business operations would be covered under the policy. It will be managed by two tier CSR Organization in DFCCIL, viz., CSR Committee at corporate level and CSR Committee at Project Implementation Unit (PIU) level. A Committee has been formed at corporate level to monitor the progress and GM (HR) is the Nodal Officer. In the approved MOU with the Ministry of Railways for the year 2011-12 targets are Rs.10 lakhs for computer literacy & Rs.10 lakhs for ECO sanitation.

The first meeting of CSR was held on 27.09.11 and it was discussed that the activities regarding computer literacy of eco-sanitation will be initially carried out in the area of CPM's Jaipur, Surat, Ahmedabad, Kanpur, Meerut & Mughalsarai. For Computer Literacy. Schools to be identified to be carried under CSR activity and also provision to be kept for AMC for maintenance so that it is a sustainable effort. It was also decided that along with Eco-Sanitation at the construction sites, we might consider the adjoining areas also. The Committee will plan out future long term CSR programme in which the possibilities of activities such as organizing trade-training programmes, vocational training programmes which will generate employment opportunities in the project affected areas may also be explored in addition to other initiatives. Further, it can be looked into possibility of adopting one or two villages where a sustainable model can be developed and an Action Plan be made based on survey, activities to be undertaken, budget allocation, the frame prescribed, major results expected and also to involve the stakeholders i.e. the affected local community. The successful model developed can be subsequently replicated in other areas.

Land Acquisition for Package 1 & 2 of Phase – I of Western Corridor Completed

The Ajmer project unit of WDFC has achieved the 100% land acquisition for package 2 of Phase-I of Western Corridor. With this declaration of award under Section 20(F) of RAA-2008 land acquisition for package 1 & 2 of phase –I of WDFC has been completed. Package 2 involves total length of 341 kms. 956 Hectares of land was acquired in 3 (Ajmer, Pali & Sirohi) district of Rajasthan & one district of Gujarat (Banaskantha) involving 140 Villages. Total project affected parties are approx. 12500. With this land acquisition for total length of 625 kms (for package 1 & 2) has been achieved wherein the work can be carried out for construction of WDFC.
