

## DFCCIL SIGNS AGREEMENTS FOR TWO MAJOR CIVIL CONTRACTS WORTH RS.4300 CRORES FOR WESTERN CORRIDOR



DFCCIL has signed two Contract Agreements for the civil works for Vaitarna to Sachin (186 km) and Sachin to Vadodara (134 Km) sections. The Contracts were signed between DFCCIL and Express Freight Consortium consisting of M/s Mitsui & Co. Ltd. (Lead

Partner), M/s Ircon International Limited & M/s Tata Projects Limited on 18.08.2015 at the DFCCIL Corporate Office, New Delhi. Sh. Adesh Sharma, MD-DFCCIL, Sh. H.D. Gujrati- Director/OP & BD, Sh. M.K. Mittal- Director/Finance, Sh. D.S. Rana- Director/Infra and other officers of DFCCIL along with various representatives of the consortium were present on the occasion.

The contracts are for complete civil works which have been awarded on design build lump sum basis at the total equivalent cost of INR 2,171 crores and INR 2,157 crores respectively. The Contracts are funded by Japan International Cooperation Agency (JICA). The project execution involves adoption of latest technology in Construction/Building e.g. use of NTC for Mechanized Track Laying capable of laying 2 kms of long welded track per day and use of premium material e.g. 60 kg Head Hardened Rails for longevity in services to be imported from Japan.

## DFCCIL AWARDS FIRST SYSTEM CONTRACT ON EASTERN CORRIDOR

Dedicated Freight Corridor Corporation of India Limited (DFCCIL) achieved yet another milestone by awarding the System Contract for Bhaupur (Kanpur)- Khurja Section of EDFC Phase- I. Contract for this 343 Km length double track line has been awarded to JV of Alstom India Ltd. (AIL) & Alstom Transport SA (ATSA) on Design Build lump sum basis at a cost of Rs. 1497 Crore. The work involves Design and Construction of Electrification, Signalling, Telecommunication, Buildings and other associated works. The Electrification work includes Traction Power Supply, Over Head Equipment (OHE) and state of art SCADA for 2X25 KV System. The Signalling and Telecommunication works include Automatic Signalling, Electronic Interlocking, Train Detection using Multi Section Digital Axle Counters (MSDAC), Train Management System,

OFC based communication system and GSM-R based Mobile Train Radio Communication etc. The Building work includes Station Buildings, Operation Control Centre (OCC), Maintenance Depots and Residential Quarters. Bhaupur-Khurja Section will have 10 stations at a spacing of 35-40 Kms of which 4 are Junction Stations connecting to Indian Railways for exchange of freight traffic. The system shall be designed to carry long Haul (1500 m.) freight trains of 13000 tons capacity at a maximum speed of 100 kmph and will improve the present average speed of 25 kmph on Indian Railway to 65 kmph. The contract for Civil Work is already awarded and the construction work is progressing at a fast pace. The complete Bhaupur - Khurja section is planned for opening during 2018. This section is being funded by World Bank.

## DFCCIL SIGNS 3 CONTRACT AGREEMENTS WORTH RS. 1063 CRORE FOR SPECIAL STEEL BRIDGES FOR WESTERN DFC

DFCCIL has signed 3 Contract agreements worth Rs. 1063 crore for the construction of 9 Special Steel Bridges spanning over various important rivers like Narmada, Damanganga, Ulhas, Par, Tapi, Yamuna & Hindon water main, creeks and Rail Flyovers at Surat, Mumbai, Vadodara and Noida of Phase 2 of Western Dedicated Freight Corridor. The contracts were signed between Dedicated Freight Corridor Corporation of India Ltd. and IIS-L&T Consortium (consisting of IHI, Japan & L&T, India).

4. डीएफसीसीआईएल कॉरपोरेट कार्यालय में एक स्वतंत्र रूप से हिंदी

# Highlights of the Quarter July-Sept. 2015

## Major Achievements

- Letter of Acceptance for Signal & Telecom Package-5A for WDFC has been issued on 12.08.2015 to M/s I-N Signal Consortium.
- Civil works on Bhaupur-Khurja section are progressing well. From July to September, 2015, 10.34 lakh cum of earthwork was executed, 8.23 km of blanket was laid and expenditure of Rs 133.15 crores was made.
- Durgawati-Sasaram Section: CRS inspection of LC gates has been done on 22.09.2015. 12 sets of canted turnouts with thick web switches, fittings, Sleepers have been laid. Besides, work on Sone Bridge between Dehri-on-Sone & Sonenagar is in full swing and 47 nos. PSC Box Girders have been launched.
- Civil works in Rewari-Iqbalgarh section under CTP-1&2 Contract: During July to September 2015, 37.41 lakh cum Earthwork (combined filling & cutting) has been carried out. 78 minor bridges have been completed and work is in progress on 320 minor bridges and 41 Major Bridges.

## Eastern DFC

- Technical bids for Civil contract package, Sahnewal-Pilkhani & Khurja-Dadri (301 & 302) were received on 16.09.2015. Total 9 bids for CP-301 (Sahnewal-Pilkhani) & 10 bids for CP-302 (Khurja-Dadri) were received. Evaluation is in progress.
- Technical bids for Electrical Works (CP- 204) in Mughalsarai-Bhaupur section were received on 22.09.2015. Total 4 proposals were received. Evaluation is in progress.
- PQ applications for civil works in Khurja – Pilkhani Section were received on 10.08.2015. Total 18 applications have been received. PQ evaluation is in progress.
- RFP and shortlist for PMC services in Khurja-Dadri & Sahnewal-Pilkhani section have been submitted for World Bank clearance on 18.09.2015 and 28.09.2015 respectively.
- PQ evaluation for Sonnagar Junction arrangement Civil works have been completed and result declared on 28.09.2015.
- Contract Agreement for engagement of consultant for Institutional Strengthening Mechanism of DFCCIL (ISMD) has been signed on 22.09.2015.
- Draft Contract Agreement for engagement of consultant for Development of Marketing and Commercial Strategies of DFCCIL (DMCSD) has been signed.
- Draft Contract Agreement for engagement of consultant for Non-discriminatory Access to DFCCIL Network (CSNDAD) has been signed.
- Combined Evaluation for QSAC services Mughalsarai – New Bhaupur has been completed. Draft contract agreement sent for World Bank clearance on 18.08.2015.

## Western DFC

- Technical bids for Civil & Track Package 3R for the section between Iqbalgarh – Vadodara has been received on 11.09.2015 and are under evaluation.
- Pre-bid conference for Civil & Track Package-11 for the section

between JNPT-Vaitarna was held on 15.07.2015. Clarification & addendum have been issued to the qualified bidders on 16.09.2015 after NOC from JICA. Date of submission is 14.12.2015.

- Technical offer for PMC Phase-II were opened on 06.07.2015. After JICA NOC to technical evaluation report, financial bids have been opened on 11.09.2015. Evaluation is under process.
- The Contract for Special Bridge Package; CTP-3A(R), for bridges on Sabarmati and Mahi rivers, was effectuated on 20.11.2014. Batching plants have been erected and hydrological report have been submitted. Sub-structure design is in progress.
- Contract Agreement for Civil & Track Package 12 & 13 for section between Vaitarna & Makarpura was signed on 18.08.2015.
- Contract Agreement for Special Steel Bridge Package 15A, 15B & 15C for construction of bridges was signed on 06.08.2015 and sent to JICA for NOC on 26.08.2015.
- Bid document for Integrated Package 14 (between Rewari-Dadri) was launched on 17.06.2015. Pre-bid meeting has been held on 24.07.2015 and bid submission is planned on 02.11.2015.
- Bid document for Signal & Telecom Package STP-17 for WDFC Phase-II (between Vadodara-JNPT) was issued on 08.06.2015. Pre-bid meeting has been held on 08.07.2015 and bid submission is planned on 19.12.2015.

## Future Corridors

- North-South Corridor – Draft PETS Report has been submitted to Railway Board on 20.05.2015. Final PETS report has been submitted by RITES on 12.08.2015.
- East-West Corridor – Draft PETS Report has been submitted to Railway Board on 20.05.2015. Final PETS report has been submitted by RITES on 12.08.2015.
- Draft Final report for East Coast Corridor has been submitted by M/s RITES on 25.08.2015.
- Work on field data collection for Southern Corridor is in progress.

## Land Acquisition

- The total award u/s 20F declared so far is 9565 Ha of land (WDFC: 5449 ha out of 6000 ha and EDFC: 4116 ha out of 5550 ha) which is approximately 86% excluding Sonnagar-Dankuni section and overall 82.8% with compensation amounting to Rs. 7483 Crs. (WDFC: 4616 Cr., EDFC: 2867 Cr.) till September, 2015.

## Human Resource

- 16 Executives (Civil, S&T and Electrical) & Manager (Law) have joined DFCCIL on permanent basis during the quarter.
- 26 Officers attended various training Conferences on overview of Companies Act, 2013, Container Infrastructure & Logistics in India, Advance Fraud Prevention and Forensic Investigation, Arbitration & Solar Power Development during the quarter.
