3	In terms of ITC sub Clause 2.3 BDS, as revised vide Notification dated 11-05-2020, Pre-Proposal conference was held on 20-05-2020 through VC. In terms of ITC sub Clause 13.1 BDS, 415 nos. Prospective Consultants' queries were clarified by the Client and six Addendums to RFP documents, as referred above, were issued.
4	In terms of NIT(On line) sub Para-16 and ITC sub Clause 17.9 BDS, as amended vide item no-62 & 68 of Addendum no-6 dated 22-09-2020, Proposals were submitted by Uploading on tenderwizard by the Consultants on 07-10-2020.
5	In terms of ITC sub Clause 19.1 BDS, as amended vide item no-69 of Addendum no-6 dated 22-09-2020, the Technical Proposals were opened on 07-10-2020 by way of downloading from Tenderwizard.

As referred above, the Technical Proposals were opened, package wise for all the three packages, by downloading from Tenderwizard, on 07-10-2020. The Technical Proposals were evaluated by a duly constituted DFCCIL Tender Evaluation Committee (TEC).

As conveyed vide Para-8 of section-I- Letter of invitation, the selection of the consultants was envisaged as 'Quality cum cost Based System (QCBS)' with weightages accorded to Technical & Financial proposals bearing a ratio of 80:20. Overall ranking of the consultants to be done ,in terms of ITC Sub Clause 27.1BDS, on the basis of overall score worked out after applying the aforesaid weightages of 80:20 to the Technical and Financial Scores achieved by the Consultant.

Next, Consultant Technical Proposals were evaluated by assigning marks on various Parameters, mentioned therein the ITC sub Clause 21.1, to arrive at the 'overall Technical Score' for a Package, as cited under ITC sub Clause 21.1 Data sheet. Consultants were required to secure minimum 70% i.e. 70 marks out of total Maximum Marks-100 Technical score to qualify for the opening of their Financial Proposals for the respective Package.

Pursuant to Technical Proposal Evaluation and as approved by the Competent Authority, the Technical Proposals of the following Consultants have been adjudged as responsive to the RFP requirements and thus qualify for the opening of their Financial Proposals. 
