This invitation for pre-qualification follows the General Procurement Notice for this project that appeared in United Nations Development Business of *10.01.2013 on-line*.

The Government of India, Dedicated Freight Corridor Corporation of India Ltd (DFCCIL) has applied loan for financing from the International Bank for Reconstruction and Development (IBRD) towards the cost of EDFC 2 Project and intends to apply part of the proceeds towards payments under the contract for Design, Supply, Construction, Testing and Commissioning of Signalling, Telecommunication and associated works of double-track railway lines under construction on a design-build lump sum basis for Mughalsarai-New Bhaupur section of Eastern Dedicated Freight Corridor. The Dedicated Freight Corridor Corporation of India Ltd. intends to prequalify contractors and/or firms for Contract package 203 as per details given above. It is expected that invitations to bid will be made in August, 2014.

Prequalification will be conducted through the procedures as specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, January 2011*, and is open to all eligible bidders as defined in the guidelines.

Interested eligible Applicants may obtain further information, and inspect the prequalification documents, from the *office of Dedicated Freight Corridor Corporation of India Ltd.* at the address below during office hours, i.e. 0930 to 1800 hours. A complete set of prequalification documents in English may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of *INR*. 10000/- or US\$ 200. The method of payment will be through demand draft or Banker's cheque drawn in favor of *Dedicated Freight Corridor Corporation of India Limited*, payable at *New Delhi*. The pre- qualification document can be obtained from the office of DFCCIL in person on any working day. If the applicant desires the document be sent by post/courier

service, then an additional charge of *INR 1000/- for inland delivery* and *INR. 5000/- or US\$ 100 for overseas delivery* shall also be paid along with the fee stated above. DFCCIL shall not be responsible for any postal delay. The pre-qualification document can also be downloaded from DFCCIL website *www.dfccil.org*. If the document is downloaded from website, the applicant must deposit the non-refundable fee of *INR 10000/- or US\$ 200* in favour of *Dedicated Freight Corridor Corporation of India Limited*, payable at *New Delhi* along with application. In case of any discrepancy between the documents downloaded by the prospective bidder and the Bid Documents (hard copy) of DFCCIL, the latter shall prevail.
