The Project Management Consulting services ("the Services") include review of designs, drawings and specifications prepared by the civil, structures, track, electrical, signal and telecom work contractors, superintendence of the contractors' performance under the contracts, progress monitoring, technical and quality control, evaluation of construction, certification and completion of works by the contractors, implementation of safety, environment and other special plans, duties related to taking over and the defect liability period.

The Dedicated Freight Corridor Corporation of India Ltd. now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.
