Name of Project: Dankuni – Gomoh section (282.22 Kms) of EDFC through PPP mode

Assignment Title: Technical Consultancy Services for Dankuni – Gomoh section (282.22 Kms) of Eastern Dedicated Freight Corridor.

1. Dankuni- Gomoh Section (282.22Kms) is Phase-I of Dankuni- Sonnagar section of EDFC to be done through PPP on Design, Build, Finance, Maintain & Transfer basis and DFCCIL intends to appoint a Technical Consultant to assist the authorities till completion of the bid process.
2. The Technical Consultancy services (“the Services”) include Review of engineering surveys, investigation reports and DPR, Review of Yard Plans, Studies & preparation of Environmental Impact Assessment (EIA) & Social Impact Assessment (SIA) reports including R&R, Preparation of Feasibility report, Preparation of Schedules A, B, C & H of the Concession Agreement, rendering technical assistance in preparation of bid document, attending pre-bid conferences and giving clarifications to bidders and Preparation of responses to technical queries on RFP from the bidders of the Project.
3. The Dedicated Freight Corridor Corporation of India Ltd. now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information as mentioned in annexure-II demonstrating that they have the relevant qualification and experience **as mentioned in Annexure-I**.
4. In case an applicant firm possesses the requisite experience and capabilities required for undertaking the Consultancy, it may participate in the Selection Process either individually (the “**Sole Firm**”) or as lead member of a consortium of firms (the “**Lead Member**”) in response to this invitation. The term applicant (the “**Applicant**”) means the Sole Firm or the Lead Member, as the case may be.
5. A Consultant shortlisted after evaluation of their ‘Expression of Interest’ will be selected in accordance with the **selection method set out in the Model RFP, Selection of Technical Consultants issued by Planning Commission, New Delhi (published in May 2009)**.
6. Expressions of interest will not be accepted electronically. Expressions of interest must be delivered in a written form in sealed cover to the address below in person along with CD both (in MS Office Word file) by **15:00 hours on 16.10.2014**.

To be eligible for this assignment, the Applicant firm shall fulfil the following:

- (A) **Technical Capacity:** The Applicant shall have, **over the past 5 (five) years,** undertaken a minimum of **1 (one)** Eligible Assignments as mentioned below.
- (B) **Financial Capacity:** The Applicant shall have received a minimum income of **Rs.45 crore (Rs. Forty five crore) or US \$ 22.5 (twenty two and half) million per annum** from professional fees during each of the three financial years preceding to the last date of submission of this EOI. For the avoidance of doubt, professional fees here under refers to fees received by the Applicant for providing advisory or consultancy services to its clients.

Eligible assignments:

Advisory/ consultancy assignments in respect of general consultancy, project management, proof checking, preparation of reports including engineering surveys and social and environmental impact assessment, for the following projects shall be deemed as eligible assignments:

- (i) Metro/ Railway projects having an estimated capital cost (excluding land) of **at least Rs. 1800 crore (Rs. Eighteen hundred crore)** in case of a project in India, and **US \$ 900 million (US \$ Nine Hundred million)** for projects elsewhere; **or**
- (ii) Any Infrastructure project involving construction and having an estimated capital cost (excluding land) of at least **Rs. 4570 crore (Rs. Four thousand Five hundred and seventy crore)** in case of a project in India, and **US \$ 2285 million (US \$ Two Thousand two hundred and eighty five million)** for projects elsewhere.

Provided that the Applicant firm claiming credit for an Eligible Assignment shall have, prior to the last date of submission to this EOI, received professional fees of at least **Rs. 457 lakh (Rs. Four hundred and fifty seven lakh)** for such assignment,

Provided further that if the Applicant firm is taking credit for an Eligible Assignment which was undertaken for a private sector entity, such assignment shall have been completed prior to the last date of submission to this EOI and the Applicant shall have received professional fees of at least **Rs. 9 crore (Rs. Nine crore)**.

- Note: 1) For all purposes of this EOI, Rs. 50 per US \$ shall be considered as the applicable currency conversion rate. In case of any other currency, the same shall first be converted to US\$ as on the date 60 (sixty) days prior to the last date of submission to this EOI, and the amount so derived in US Dollars shall be converted into Rupees at the aforesaid rate. The conversion rate of such currencies shall be the daily representative exchange rates published by the International Monetary Fund for the relevant date.
- 2) A harmonized list of Infrastructure sub-sector for Govt. of India shall be considered for all purposes of this assignment.
