- 1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in UN Development Business issue of 08 February, 2010.
- 2. Government of India has applied for financing from the World Bank and intends to apply part of the proceeds for Engineering Consultancy Services for Single Line / Double Line Electrified (2X25 KV) Railway Track complete with Signaling & Telecommunication system and related infrastructure for Mughalsarai-Bhaupur Section (Approximately 390 Route Km double line) and Dadari-Khurja-Ludhiana section (Approximately 46 Route Km double line and 397 Route Km single line) of Eastern Dedicated Freight Corridor.
- The construction work of (i) Mughalsarai-Bhaupur Section and (ii) Dadri-Khurja-Ludhiana section is proposed to be tendered on 'Design-Build' (Lump Sum) basis. For each section, there will be two contract packages: (i) Civil, Structure & Track Works (to be tendered on slice and package method and may consist of maximum 3 slices) and (ii) System Works (Electrical, Signal & Telecommunication Works). The services will include preparation of Pre-qualification and Bidding Documents for the procurement (through ICB) of all the four packages (2 packages for each section) and assistance to DFCC in bid process management including bid evaluation and finalization of contract agreement.
- 4. The DFCC now invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide all the information mentioned in the annexure indicating that they are qualified to perform the services. Consultants may associate to enhance their qualifications.
- 5. Consultant will be selected in accordance with the procedures set out in the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers January 2011.

- 7. Expression of interest must be delivered to the address below no later than 15:00 hrs on 01.06.2011.

² For the purpose of brevity of information, the consultancy work pertaining to Railway lines of more than 50 Track Km should only be included.

³ Only those assignments should be included, which have been carried out by the applicant. The assignments carried out by parents/ sister companies should not be included.

⁴ Components of assignment should be indicated as:

i) design/ design review of a) railway alignment, b) railway track system c) structures, d) traction power supply, e) electrical OHE, f)SCADA, g) railway signaling h) communication

ii) development of technical/ performance specifications for the items included in i) above

iv) bid document preparation

v) bid processing/bid evaluation

vi) Any other component (details to be indicated)
