PROCEEDINGS OF VIGILANCE AWARENESS WEEK-2013

On the occasion of the Vigilance Awareness Week-2013 , following activities were undertaken in the Head Office as well as in the Unit offices:-

1. Display of Banners:

Banners of Vigilance Awareness Week-2013 were displayed in the Corporate Office/New Delhi as well as in all Project Offices.

2. Pledge Taking Ceremony:

Corporate Office

As per schedule the pledge taking ceremony was held in the Corporate office on 28th October, 2013. All the Directors/GGMs/GMs/DGMs/Managers and other staff of DFCCIL participated in the ceremony and were administered the oath to stay away from any kind of wrongdoing in the discharge of their official functions. Speaking on the occasion, Shri R.K.Gupta, Managing Director/DFCCIL told the officials that the main purpose of the Vigilance Awareness Week is to spread the awareness about the ill effects of corruption and how to combat it. The attention was drawn to the main theme of the Vigilance Awareness Week of the year i.e. **'The positive contribution of vigilance in promoting good governance'** in the organization. In the end he sensitized the functionaries about the transparency/integrity in all the spheres of their activities.

Similarly all the Project Units of Eastern & Western Corridor of DFCCIL, observed the Vigilance Awareness Week.

3. Vigilance Conference

A Vigilance conference on **'Positive contribution of the Vigilance Administration in Promoting the Good Governance'** was organized on 30th October, 2013 in Corporate Office/New Delhi in which apart from M.D and all the CPMs as well as all officials of corporate office participated. Sh. Ramesh Chandra, Chief Technical Examiner of Central Vigilance Commission was the Chief Guest to honour the occasion. The deliberations of the event are as under:-

i) Welcome address by Shri Vijender Singh Dy. CVO/DFCCIL.



The proceedings of the conference were initiated by Shri Vijender Singh, Dy. CVO/DFCCIL by welcoming the Chief Guest Sh. Ramesh Chandra, Chief Technical Examiner of Central Vigilance Commission and other participants to the seminar on the occasion.

ii) Welcome address by Shri R. K. Gupta, Managing Director/DFCCIL

MD welcomed the CTE and briefed the gathering about the progress of land acquisition and various other activities under progress in Eastern Corridor & Western Corridor. The problems which are being faced were also discussed.



iii) Presentation by Sh. D.S.Rana, CPM/Jaipur on the subject of "Promoting Good Governance- Positive Role of Vigilance".



On the occasion Sh. D.S. Rana, CPM/Jaipur gave a presentation on **"Promoting Good Governance- Positive Role of Vigilance"** to spread the awareness about the subject theme amongst the participants. The salient ingredients of good governance were discussed along with necessary inputs and enabling features for each one of them. The role of Vigilance in ensuring good-governance was discussed through various actual Case-Studies, wherein sound Management practices have been brought back into the Organization/Departments through various System Improvements/Interventions and Checks by the Vigilance.

During the discussion, another aspect of Vigilance dealing with proactive support to Management / Organizational Objectives, but often, remains hidden or noticed for the Employees of any organization was also deliberated upon.

iv) Presentation given by Sh. Ajay Kumar, GGM/EC on the subject of Transparency on Procurement.



The presentation covered the issues of how to ensure transparency in procurement process and included detailed discussion on the following topics:-

- i) General Procurement Notice & its salient features.
- ii) Specific Procurement Notice & Request for Expression of interest including the stages of bidding involved.
- iii) Works Contract, bid documents, PQ documents & Works Contracts procedures & precautions to be taken in the preparation of these documents.
- iv) Consultancy Contracts & procedures for the same.

v) Presentation by Sh. Ramesh Chandra, Chief Technical Examiner/CVC



Speaking on the occasion, Sh. Ramesh Chandra, Chief Technical Examiner/CVC stressed on the need of transparency in procurement process to maximize the potential for fare competitive bidding and enhance integrity. He also laid emphasis on easy accessibility of key documents to all stakeholders and that the specifications are unbiased. Also the procurement regulations and systems must not be unnecessarily complex, costly and time consuming as they could cause heavy delay in the entire procurement process.

Therefore, ensuing an adequate level of transparency will enhance corruption control with impeding efficiency and effectiveness of procurement process.

4. Essay Competition

An essay Competition was also organized and entries on the topic of 'Promoting the Moral Values, Ethics, Good Governance Practices in DFCCIL' were invited from all the willing officials of DFCCIL. Winners in this competition were suitably awarded.
