The Dedicated Freight Corridor Corporation of India Ltd. (DFCC) intends to apply for financing for the amount of US \$ 650 million equivalent from the World Bank toward the cost of the Eastern Dedicated Freight Corridor Project-3 and DFCC intends to apply part of the proceeds to payments of goods, works, related services and consulting services to be procured under this project

EDFC Project 3 involves construction of single line electrified track of about 404 route km. between Khurja-Meerut-Saharanpur-Ambala-Sahnewal (near Ludhiana) and about 46 Km of electrified double line connecting Khurja and Dadri; where it links with Western Corridor of DFC.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's Guidelines under IBRD Loans and IDA Credits January 2011 and is open to all eligible bidders as defined in the guidelines. Consulting services will be selected in accordance with the World Bank's Guidelines: Selection and Employment of Consultants by World Bank Borrowers January 2011.

Specific procurement notices for contracts to be bid under the World Bank's International Competitive Bidding (ICB) procedures and for contracts for consultancy services will be announced as they become available, in UN Development Business, leading National Hindi/English daily and DFCCIL website.
